Whereas, Sh. Bikram Singh, TGT (NM) preferred CWP No. 3030/2024 titled as Bikram Singh Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GHS Kiyao 15/20 District Shimla to the station nearby his native place Distt. Kangra, against vacancy/ longer stayee. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 09.04.2024 when the Hon'ble High Court has passed the following orders:-

*"3. Prayer being innocuous is not opposed. Accordingly, the petition is disposed of by directing respondent No. 2 to consider and decide the representation of the petitioner Annexure P-3 within ten date of production of this order. Pending applications, if any, also stand disposed of."*

In compliance of the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 07.05.2024. He has attended the same and submitted his representation in this office on 07.05.2024 vide which he has requested that he has completed normal tenure at his present place of posting i.e GHS Kiyao 15/20 District Shimla, H.P and he further requested that he may be transferred to Distt. Kangra, against vacancy/ longer stayee by clubbing his/her previous stay. Petitioner has given five stations of his choice in District Kangra.

Whereas, from perusal of record, it has been found that the petitioner is working at GHS Kiyao 15/20 District Shimla w.e.f. 01.03.2021 and has completed three years at present place of posting. One Sh. Balbir Singh TGT (NM) is working in GSSS Bharmar, Distt. Kangra since 08.08.2022. The petitioner has given willingness for his transfer to the aforesaid school against longer stay by clubbing his previous stay within radius of 30 Kms. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetically, and he is hereby transferred without TTA from GHS Kiyao 15/20 District Shimla to GSSS Bharmar, Distt. Kangra, vice Sh. Balbir Singh, TGT (NM) against longer stay by clubbing his previous stay within radius of 30 Kms. with TTA/JT to Sh. Balbir Singh, TGT (NM). The representation of the petitioner is disposed of accordingly.
