In the matter of: CWP. No. 3385/2024-titled as Bhavna, TGT (NM) Vs. State of H.P. & Others.

Whereas, Smt. Bhavna, TGT (NM) GSSS Daron Deveria, Distt. Sirmour has filed CWP No. 3385/2021-titled as Bhavna, TGT (NM) Vs. State of H.P. before the Hon'ble High Court of H.P regarding transfer from GSSS Daron Deveria, Distt. Sirmour to Distt. Kangra, against vacancy/ longer stayee. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 26.04.2024 when the Hon'ble High Court has passed the following orders:-

"This writ petition is accordingly disposed of with the direction that the representation filed by the petitioner be decided in light of the averments made therein within a period of four weeks from today. Pending miscellaneous application(s), if any also stand disposed of accordingly."

In compliance to the directions of the Hon'ble High Court the petitioner has attended personal hearing on 20.05.2024 and submitted her representation wherein she has requested that she may kindly be adjusted in Distt. Kangra against vacancy or longer stayee by clubbing previous stay within the radius of 30 Kms.

On the perusal of the record, it reveals that Smt. Bhavna, TGT (NM) is working in GSSS Daron Deveria, Distt. Sirmour since February, 2022 and having short stay at her present place of posting as she has not completed three years of stay as per policy framed by the Government.

Therefore, keeping in view the position stated above, request made by Smt. Bhavna, TGT (NM) on 20.05.2024 cannot be considered at this stage and the same is hereby rejected. The representation of the petitioner is disposed of accordingly.

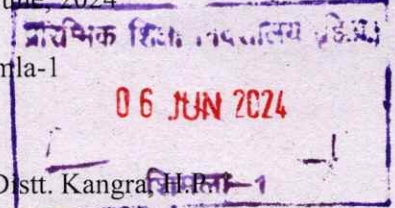
