In the matter of: CWP No. 1911/2024 titled as Anju Devi, TGT (NM) Vs. State of H.P. & ors.

Whereas, Anju Devi, TGT (NM) preferred CWP No. 1911/2024 titled as Anju Devi Vs. State of H.P. before the Hon'ble High Court of H.P. regarding her transfer from GMS Kutharna u/c GSSS Kanol, District Kangra to the station nearby in Jaisinghpur Tehsil Distt. Kangra, against vacancy/ longer stayee. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 14.03.2024 when the Hon'ble High Court has passed the following orders:-

*"4. Taking into consideration the statement so made by learned Advocate General, the petition is disposed of by observing that let the representation of the petitioner (Annexure P-2) be decided by the Competent Authority within a period of six weeks from today and if possible the petitioner be adjusted at the station of her choice in case such station is vacant.*

*Pending miscellaneous applications, if any also stand disposed of."*

In compliance of the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 06.06.2024. She has attended the same and submitted her representation in this office on 06.06.2024 vide which she has requested that she has completed normal tenure at her present place of posting i.e GMS Kutharna u/c GSSS Kanol, District Kangra, H.P and she further requested that she may be transferred to Tehsil Jaisinghpur Distt. Kangra, against vacancy/ longer stayee by clubbing his/her previous stay.

Whereas, from perusal of record, it has been found that the petitioner is working at GMS Kutharna u/c GSSS Kanol, District Kangra w.e.f. 21.02.2017 and has completed more than three years at present place of posting. One Sh. Sanjeev Kumar TGT (NM) is working in GMS Sandroa u/c GSSS Kosri, Distt. Kangra since 25.11.2021. The petitioner has given willingness for her transfer to the aforesaid school against longer stay by clubbing his previous stay within radius of 30 Kms. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetically, and she is hereby transferred without TTA from GMS Kutharna u/c GSSS Kanol, District Kangra to GMS Sandroa u/c GSSS Kosri, Distt. Kangra, vice Sh. Sanjeev Kumar, TGT (NM) against longer stay by clubbing his previous stay within radius of 30 Kms. with TTA/JT to Sh. Sanjeev Kumar, TGT (NM). The representation of the petitioner is disposed of accordingly.
