Whereas, Sh. Narender Pal, TGT (NM) preferred CWP No. 4025/2024 titled as Narender Pal Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GMS Lassi, U/C GSSS Chhatri, Distt. Mandi to nearby station at his native place in Distt. Mandi, H.P. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 14-05-2024 when the Hon'ble High Court has passed the following orders:-

"3.This writ petition is accordingly disposed of with the direction that the representation made by the petitioner, appended with the writ petition as Annexure P-4, dated 15-04-2024, shall be decided by the competent authority, in light of the averments made therein, within a period of four weeks from today. Pending miscellaneous application(s), if any, also stand disposed of accordingly."

In compliance with the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 06-06-2024. He attended the same and submitted his representation in this office, vide which he has requested that he has completed required tenure at his present place of posting i.e GMS Lassi U/C GSSS Chhatri, Distt. Mandi, H.P and he may be transferred to nearby home station in Distt. Mandi, H.P against vacancy/ longer stayee by clubbing his/her previous stay.

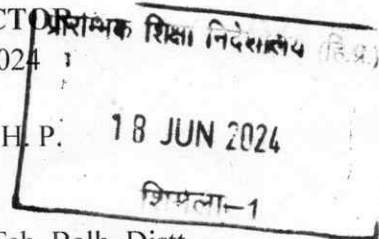
From perusal of record, it has been found that the petitioner has been working at GMS Lassi, U/C GSSS Chhatri, Distt. Mandi, H.P. w.e.f. 11-11-2019 and has completed four years stayat present place of posting. Moreover, TGT(NM) is State Cadre post and the incumbents supposed to serve anywhere in the State as per requirement and administrative exigency. At present 06 students are studying in GMS Lassi, U/C GSSS Chhatri, Distt. Mandi and only one TGT is working there . If the petitioner will be transferred from there the studies of students will suffer adversely. Therefore, after critical examination and thoughtful application of mind the request made by the petitioner is hereby rejected on administrative ground and in larger public interest. The representation of the petitioner is disposed of accordingly.

Whereas, Sh. Anil Kumar, TGT (NM) preferred CWP No. 3245/2024 titled as Anil Kumar Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GHS Sulpur Bhai, Distt. Mandi to GMS Thachadhar, U/C GSSS Gadagussaini, Distt. Mandi, H.P. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 22-04-2024 when the Hon'ble High Court has passed the following orders:-

"2. In the event of any such representation being filed within two weeks, let appropriate decision thereupon be taken by the competent Authority, within six weeks as from the date of the receipt thereof."

In compliance with the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 07-06-2024. He attended the same and submitted his representation in this office, vide which he has requested that he may be transferred/ adjusted at nearby home station at Baldwara and Sarkaghat in Distt. Mandi, H.P against vacancy/ longer stayee by clubbing his/her previous stay.

From perusal of record, it has been found that the petitioner has been working at GHS Sulpur, Distt. Mandi, H.P. since June, 2022 and under transfer to GMS Thachadhar, U/C GSSS Gadagiussaini, Distt. Mandi, H.P. Moreover, TGT(NM) is State Cadre post and the incumbents supposed to serve anywhere in the State as per requirement and administrative exigency. The petitioner Sh. Anil Kumar TGT(NM) has ~~been~~ already joined at GMS Thachadhar, U/C GSSS Gadagussaini, Distt. Mandi on dated 30-04-2024. Therefore, after critical examination and thoughtful application of mind the request made by the petitioner is hereby rejected on administrative ground and in larger public interest. The representation of the petitioner is disposed of accordingly.

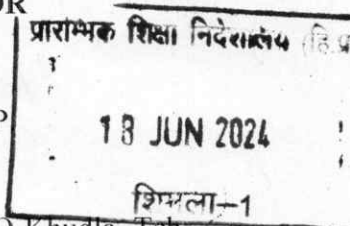
