Note:- While implementing above transfers of teachers the norms and standards for providing teachers in a school as contained under Sr. No.1(a) in the schedule of RTE Act 2009 be complied strictly. In case any violation of these instructions you will be entirely responsible.

- These orders may be implemented in relaxation of ban on transfers.
- If the incumbent has already served Sub-cadre/hard/tribal/difficult area in that event he/she may not be relieved again to areas ibid.
- It must be ensured that the candidate is not specially abled.
- It must be ensured that the incumbent is not on the verge of retirement.
- The transfer orders of TGTs issued from hard area to soft area may not be implemented without joining of substitute.
- If incumbent (s) who has/have not completed three years tenure in his/her present place of posting, transfer orders may not be implemented, if stay of the incumbent (s) not condoned.
- All provisions as contained in O/M No:PER (AP-3) E(3)17/2021 dated 10.07.2013 "Comprehensive Guiding Principles 2013--- for regulating the transfer of State Govt. Employees at point No.5" concession to certain categories of employees and 5.6. of O/M dated 17.9.15 must be adhered strictly.
