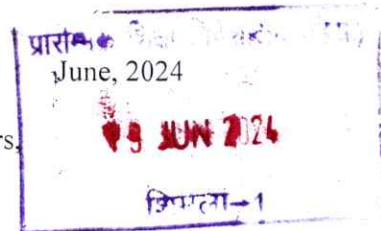

Subject:- Annual targets of school inspections regarding learning outcomes.


Sir,

On the subject cited above, it is intimated that the quality of learning outcomes is a matter of concern for all the stakeholders including parents, teachers, supervisory officers and policy makers. Various interventions have been introduced in schools to improve the quality of education. However, despite all these efforts, the results are not up-to the mark and we need to look into it from all perspective particularly the efforts regarding monitoring and supervision need to be strengthened.

In view of the above, it has been decided that during each month of each academic session, the Block Elementary Education Officers shall conduct at least Two (02) school inspections in each cluster primarily focusing on the learning outcomes of the students. It shall also be noted that in each cluster, different schools shall be selected for inspection in each academic year on rotation basis. The inspection schedule for the next academic session shall be issued by the BEEO in advance to the concerned schools in the 1st week of March every year with a copy to the Deputy Director Elementary Education and to this Directorate at email Id qualitycellhq@gmail.com. However, for the ongoing academic session, the schedule of inspection shall be issued well before 15th June, 2024. The inspecting authorities shall proceed on inspection with full preparation as per the requirement of inspection reporting format so that the purpose of inspection is fully realized as per the spirit. **The inspecting Officer shall ask at least two (2) questions of each subjects in each class and record his/her observation on the prescribe format.** The revised format for inspection report is enclosed herewith at Annexure A. The inspection report shall be sent to this Directorate on monthly basis at the above email Id.

These directions be implemented in letter and spirit and any negligence in this regard shall be viewed seriously. The achievement of the Deputy Director concerned against his annual target of inspection shall be reflected in his Annual Confidential Report.
