The Petitioner,Smt. Rajni Kumari,TGT (Med),filed CWP No. 5471/2024 titled as, Smt.Rajni Kumari,TGT,(Med) Vs State of H.P. before the Hon'ble High Court of H.P. aggrieved her transfer from GSSS Kot (HMR) to GSSS Kangar Dharyar Distt. Sirmour .The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 15th June.2024, when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions/ order:-

"After making his submissions for some time ,learned Counsel for the petitioner prays for and is permitted to withdraw the petition.He Submits that the petitioner be allowed to file a representation for her adjustment at some other station.Liberty granted,as prayed for.In case any representation is filed by the petitioner for her adjustment at some other station within two weeks from today,then the same be decided within one week as from the date of receipt thereof.Till the decision on representation of the petitioner ,she be not forced to join the station to which she stand transferred and she may avail the leave of kind due.However,it is made clear that this Court has not expressed any opinion on the merits of the case.Accordingly ,the petition stands disposed of ,so also pending miscellaneous applications,if any."

As per direction of the Hon'ble High Court the petitioner submitted her representation to the undersigned, in which she has requested that she may be adjusted in GSSS Manoh /GSSS Ladrou / GSSS Mair / GSSS Barsar/ GSSS Dandru Distt. Hamirpur against longer stay or by clubbing previous stay.The petitioner has further stated that her husband is serving with the Centre Government and is presently posted at Delhi and her father in law is old and suffering from various ailments. As such there is no one of the family to look after the old ailing mother in law and one miner daughter .

From the perusal of the record, it reveals that Smt. Rajni Kumari , TGT (Med) is presently u/t from from GSSS Kot (HMR) to GSSS Kangar Dharyar Distt. Sirmour.At present there is no vacancy in above said institution mention by the petitioner mentioned by the petitioner. Moreover,in GSSS Kangar Dharyar Distt. Sirmour 63 students are studying from class VI to X.In the interest of the student post of TGT(Med) cannot be kept vacant.Therefore,keeping in view of the position state above ,the representation made by the petitioner can not be acceded to and hereby rejected and disposed of accordingly.
