State of H.P. before the Hon'ble High Court of H.P regarding his transfer/adjustment in nearby his native place Distt. Kangra. The above writ petition was listed before the Hon'ble High Court Himachal Pradesh on 25.06.2024 when the Hon'ble High Court has passed the following orders:-

*"4. Accordingly, as prayed for, this writ petition is disposed of with liberty to the petitioner to file a representation to the respondents for his adjustment at some other convenient station within a period of one week from today. In the event of any such representation being filed by the petitioner within the time granted, then the same be decided by the competent Authority, sympathetically, in view of the averments contained therein, by passing a speaking order, within a period of six weeks from the date of receipt thereof, in accordance with transfer policy of the State.*

*Pending miscellaneous application(s), if any, also stand disposed of accordingly."*

In compliance of the aforesaid orders of the Hon'ble High Court the petitioner has Submitted his representation in this office on 26.06.2024 vide which he has requested that he has completed normal tenure (by clubbing) at his present place of posting i.e GSSS Khaniara Khas, Distt. Kangra, H.P and he further requested that he may be transferred/adjusted in Distt. Kangra, against vacancy/ longer stayee by clubbing his/her previous stay.

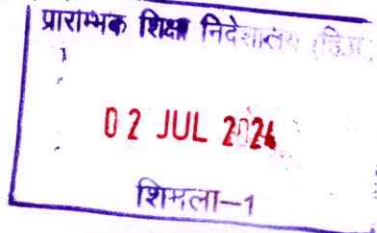
Whereas, from perusal of record, it has been found that the petitioner is working at GSSS Khaniara Khas, Distt. Kangra since 2022 and has completed three years stay at present place of posting (by clubbing). The petitioner has served last seven years within the radius of 30 Kms. The aforesaid school falls in soft area and petitioner is not entitled for transfer to the station of his choice. Moreover, TGT (NM) is State Cadre post and the incumbent supposed to serve anywhere in the State as per requirement and administrative exigency. At present there are 35 students in GMS Dhabrain u/c GSSS Sach, Distt. Chamba and if no teacher joins in the school the studies of student would be adversely affected. Therefore, after critical examination and thoughtful application of mind the request made by the petitioner is hereby rejected on administrative ground and in larger public interest. The representation of the petitioner is disposed of accordingly.

**ORDER**

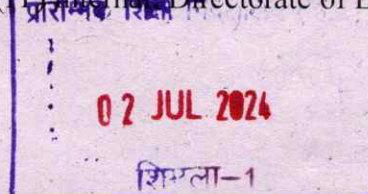
