The Petitioner, Smt. Neeta Devi, TGT (Med), filed CWP No. 5013/2024 titled as, Smt. Neeta Devi, TGT, (Med) Vs State of H.P. before the Hon'ble High Court of H.P. regarding seeking her transfer from GHS Shivpur u/c G(M)SSS Bhawai Distt. Sirmour(which falls under Hard area), after the completion of required tenure as per policy. The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 31<sup>st</sup> June, 2024, when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions/order:-

"Taking into consideration the above grievance this writ petition is disposed of by directing respondent No.2/competent authority to consider and decide the representation of the petitioner dated 19-02-2024(Annexure P-3,16-03-2024(Annexure P-4) and 8-04-2024 (Annexure P-5) in accordance with law and applicable decision so arrieved at shall also be communicated to the petitioner.

The writ petition stands disposed of in the above terms, so also the pending miscellaneous application(s) if any."

As per direction of the Hon'ble High Court the petitioner submitted her representation to the undersigned, in which she has requested that she may be adjusted in GHS Nandpur u/c GSSS Thathal /GHS Bane–Di-Hatti /GHS Baruhi/GSSS Kinnu Distt. Kangra against longer stay or by clubbing previous stay. The petitioner has further stated that her parents in law as old and suffering from various ailments. As such there is no one of the family to lock after the old ailing parents-in law.

From the perusal of the record, it reveals that Smt. Neeta Devi, TGT (Med) is presently working in GHS Shivpur u/c GMSSS Bhawai Distt. Sirmour since 23<sup>rd</sup> Feburary, 2021 (which fall under hard area). At present there is no longer stayee in above said institution mention by the petitioner. Moreover, in GHS Shivpur u/c GMSSS Bhawai Distt. Sirmour 85 students are studying from class VI to X. In the interest of the student post of TGT (Med) cannot be kept vacant. Therefore, keeping in view of the position state above, the representation made by the petitioner can not be acceded to and hereby rejected and disposed of accordingly.

## **ORDER**

In the matter of:

CWP No: 5293/2024-titled as Kewal Singh V/s. State of Himachal Pradesh.

The petitioner has filed CWP No. 5293/2024 titled as Kewal Singh V/s State of H.P. in the Hon'ble High Court against his transfer order dated 19.06.2024 and seeking his adjustment from GSSS Nihalgarh (SMR) to GMS Dhab Pipli u/c GMSSS Sataun (SMR) against vacancy. The case was listed before the Hon'ble High Court of H.P. on 26.06.2024, on this day Hon'ble Court has passed order/judgment. The Operative portion of the present CWP judgement is as under:-

"Accordingly, as agreed, this petition is disposed of with the direction that in the event of petitioner filing a representation within three days from today, for his adjustment at some other station, the same shall be sympathetically considered and decided by the Authority, within a period of one week as from the date of the receipt thereof. Till then the petitioner shall not be forced to join the station to which he stands transferred in terms of the impugned order."

In compliance to the aforesaid orders passed by the Hon'ble High Court of Himachal Pradesh, the petitioner i.e Sh. Kewal Singh, TGT (Arts) submitted the representation on dated 27.06.2024 wherein he stated that he was transferred from GSSS Nihalgarh (SMR) to GHS Siun u/c GSSS Sangrah (SMR) that is sub cadre area and he had already served in a hard area i.e. Dodra Kwar (Shimla), therefore requested to adjust at GMS Dhab Pipli u/c GMSSS Sataun (SMR) against vacancy.

From the perusal of record, it is found that Sh. Kewal Singh, TGT (Arts) is working at GSSS Nihalgarh (SMR) since 07.07.2023, but serving within the radius of 30 kilometers. The continuous services rendered by employees of Education Department within a radius of 30 Kms. be considered stay/tenure at one station & such services will be clubbed for calculation of tenure purpose of transfers. The petitioner has been serving within the radius of 30 kilometers despite the fact that TGT (Arts) is State Cadre post and the incumbents are supposed to serve anywhere in the State in the exigencies of the service.

Keeping in view, the above facts and circumstances, the case of the petitioner for adjustment is considered and hereby adjusted at GHS Thaina Basotri u/c GSSS Phagoo (SMR) (Soft Station) against vacancy, whereas 67 students (Aprx) studying, as the SMC of GHS Thaina Basotri has requested to fill the post of TGTs through their resolution dated 25.04.2024 as well as on CM helpline.
