Whereas, Sh. Susheel Kumar, TGT (NM) preferred CWP No. 4377/2024 titled as Susheel Kumar, Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GSSS Kholanal, Distt. Mandi, H.P. to nearby station at his native place in Distt. Hamirpur and Mandi, H.P. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 21-05-2024 when the Hon'ble High Court has passed the following orders:-

5. "In view of above submissions, the instant writ petition is disposed of by permitting the petitioner to make a fresh representation to respondent No.2/ competent authority within a week from today, who shall in turn, consider and decided the same, in accordance with law and applicable policy, within a further period of three weeks. Theorder so passed be also communicated to the petitioner. Pending miscellaneous application(s), if any shall also stand disposed of."

In compliance with the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 14-06-2024. He attended the same and submitted his representation in this 'office on 14-06-2024, vide which he has requested that he has completed required tenure at his present place of posting at GSSS Kholanal, Distt. Mandi, H.P and he may be transferred to nearby native place in Distt. Hamirpur, H.P, against vacancy/longer stay by clubbing his/her previous stay radius of 30 Kms. At present there is no vacancy at in District Hamirpur, H.P.

From perusal of record, it has been found that the petitioner has been working at GSSS Kholanal, Distt. Mandi, H.P w.e.f July, 2019 and has completed five years stay at present place of posting. At present (46) students are studying in GSSS Kholanal, Distt. Mandi, H.P and (2) TGTs are working there. If the petitioner will be transferred in mid academic session from there the studies of students will suffer adversely. Therefore, after critical examination and thoughtful application of mind the request made by the petitioner is hereby rejected on administrative ground and in larger public interest. The representation of the petitioner is disposed of accordingly.

Mandi, if the petitioner is allowed to moved out from the school as per his request, the students will suffer in terms of their study. Therefore after critical and thoughtful examination of the case, the request made by the the petitioner is rejected on administrative ground and in larger public interest. The representation of the petitioner is disposed of accordingly.

From the perusal of the record, it reveals that Smt. Saroj Bala, TGT (Med) is presently working in GSSS Kaobil 15/20 Distt. Shimla (which falls under Hard area) since 25th feburary,2021. As per version of the teacher there are 56 student are studying in GSSS Kaobil 15/20 Distt. Shimla. The result of the school for Board class Xth is zero percent , which shows that she has not been serious in imparting education to the student and has not done her duty well. It is mid session and she should teach her students in proper manner. Therefore after critical and thoughtful examination of the case, the request made by the the petitioner is rejected on administrative ground and in larger public interest. The representation of the petitioner is disposed of accordingly.

## **ORDER**

In the matter of:

CWP No: 4394/2024-titled as Karam Singh V/s. State of Himachal Pradesh.

The petitioner has filed CWP No. 4394/2024 titled as Karam Singh V/s State of H.P. in the Hon'ble High Court and seeking his transfer from GSSS Behli,(MND) to any one station mentioned in representation against vacancy or longer stayee by clubbing their stay of previous stations within the radius of 30 Kms. The case was listed before the Hon'ble High Court of H.P. on 21.05.2024, on this day Hon'ble Court has passed order/judgment. The Operative portion of the present CWP judgement is as under:-

"Learned vice counsel for the petitioner states that since the petitioner intends to represent to the respondents, therefore, he does not want to pursue this writ petition and that he may be permitted to withdraw the same. His statement is taken on record. Accordingly, the writ petition is dismissed as withdrawn. Pending miscellaneous application(s), if any, also stand disposed of."

In compliance to the aforesaid orders passed by the Hon'ble High Court of Himachal Pradesh, the petitioner i.e Sh. Karam Singh, TGT (Arts) has attended the personal hearing on 15-06-2024 and has submitted representation, wherein request to transfer him from GSSS Behli (MND) to GSSS Kapahi vice Sh. Yog Raj being longer stayee or GHS Kothi u/c GSSS Gurkotha (MND) against vacancy, in view of his domestic problems.

From the perusal of record, it is found that Sh. Karam Singh, TGT (Arts) is working at GSSS Behli, (MND) since 19.12.2020 whereas the enrollment of students is 148 (Aprx.) and two TGTs (Arts-1, Medical-1) are lying vacant in the said school, if the petitioner is transferred from the school as per his request, the students will be left to their fate and will adversely suffer in terms of their study.

Keeping in view the position stated above, representation of petitioner i.e Sh. Karam Singh, TGT (Arts) can not be considered at this stage due to non vacancy and the transfer will affect the study of students in the mid acadmic session. Hence, request made by the petitioner is hereby rejected and disposed of accordingly.
