**ORDER**

In the matter of: CWP No. 5381/2024-titled as Rakesh Kumar V/s State of Himachal Pradesh and others (Regarding Transfer).

In compliance of the order/judgment passed by the Hon'ble High Court of Himachal Pradesh dated 13-06-2024 in present case that the petitioner (Rakesh Kumar, TGT (Arts) was called for personal hearing on 09-07-2024 and appeared before the undersigned on scheduled date. At the time of hearing he has submitted fresh representation and requested his transfer from GMS Jashla u/c GSSS Deori Khaneti, Distt. Shimla to GHS Fatehwal u/c GSSS Jakhera/GMS Dobar u/c GSSS Raipur Maidan/GHS Jhorowal u/c GSSS Nangran, Distt. Una or GMS Jol u/c GSSS Dangar/GMS Hari Talyana u/c GSSS Dangar/GMS Bari Chauk u/c GSSS Marhana/GMS Bhadsin u/c GSSS Bharari, Distt. Bilaspur, against vacancy.

From perusal of the record it reveals that the petitioner Sh. Rakesh Kumar, TGT (Arts) is working at GMS Jashla u/c GSSS Deori Khaneti, Distt. Shimla since 16-06-2017 and has completed his normal tenure at present place of posting. Rakesh Kumar, TGT (Arts) is considered sympathetically and he is hereby transferred from GMS Jashla u/c GSSS Deori Khaneti, Distt. Shimla to GHS Jhorowal u/c GSSS Nangran, Distt. Una, against vacancy on his own request. Therefore, representation of the petitioner with the present CWP is disposed of accordingly.

Whereas, Smt. Ankush Lata, TGT (NM) preferred CWP No. 5891/2024 titled as Ankush Lata, TGT(NM) Vs. State of H.P. before the Hon'ble High Court of H.P. regarding her transfer from GSSS Khood, Distt. Sirmour, H.P. to nearby home station in Distt. Una, H.P. against vacancy or against longer stayee by clubbing his/her previous stay. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 27-06-2024 when the Hon'ble High Court has passed the following orders:-

"3. Taking into consideration the fact that the request of transfer was made by the petitioner in the month of May, 2024, in terms of Annexure P-1, appended with the petition, this petition is disposed of with the direction that appropriate order on the representation of the petitioner be passed by the competent authority within a period of four weeks from today and taking into consideration the fact that the petitioner has already completed more than three years of service at her present place of posting, endeavor be made to place the petitioner at a station of her choice, if possible. However, in case the station of her choice is not available, then the petitioner may be transferred to some other place, which is not a backward/hard area. pending miscellaneous application(s), if any also stands disposed of."

In compliance with the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 09-07-2024. She attended the same and submitted her representation in this office, vide which She has requested that She has completed required tenure at her present place of posting and She further requested that She may be transferred to nearby home station in Distt. Una, H.P, against vacancy/against longer stayee by clubbing his/her previous stay.

Whereas, from perusal of record, it has been found that the petitioner is working at GSSS Khood, Distt. Sirmour, H.P w.e.f. 22-02-2021 and has completed the normal tenure of three years. The petitioner has given willingness for his transfer to GSSS Samoor Kalan, Distt. Una, H.P, against vacancy being caused due to retirement of present incumbent on 31-07-2024. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetically, and She is hereby transferred without TTA/ JT from GSSS Khood, Distt. Sirmour, H.P to GSSS Samoor Kalan, Distt. Una, H.P, against vacancy being caused due to retirement of present incumbent on 31-07-2024. The petitioner will join in the allotted station after 31-07-2024. The representation of the petitioner is disposed of accordingly.
