In the matter of: CWP No. 5427/2024 titled as Sandlan Devi, TGT (NM) Vs. State of H.P & ors.

Whereas, Smt. Sandlan Devi, TGT (NM) who is u/t from GSSS Mair, Distt. Hamirpur to GMS Samvi u/c GSSS Tikkar, Distt. Shimla has filed CWP No. 5427/2024 titled as Sandlan Devi, TGT (NM) Vs. State of H.P. before the Hon'ble High Court of H.P regarding her transfer/adjustment in nearby her native place Distt. Hamirpur. The above writ petition was listed before the Hon'ble High Court Himachal Pradesh on 14.06.2024 when the Hon'ble High Court has passed the following orders:-

"4. Accordingly, without interfering with the impugned transfer order, this petition is disposed of with the direction that in the event of the petitioner filing a representation for her adjustment at some other convenient station within a period of one week from today, then let said representation be decided by the competent Authority, sympathetically, in light of the medical certificates appended with the representation to be filed by the petitioner and an endeavour be made for her adjustment at some convenient station in terms of the contents of the representation, within a period of three weeks as from the date of receipt thereof. Till then, the petitioner shall not be forced to join at the new place of posting and she is at liberty to avail kind of leave due to her.

It is clarified that this Court has not interfered with the order of transfer of the private respondent. Pending miscellaneous application(s), if any also stand disposed of accordingly."

In compliance of the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 25.06.2024. She has attended the same and submitted her representation in this office on 25.06.2024 vide which she has requested that she has completed normal tenure (by clubbing) at her present place of posting i.e GSSS Mair, Distt. Hamirpur, H.P and she further requested that she may be transferred/adjusted at GSSS(B) Kunihar, Distt. Solan, against vacancy.

Whereas, from perusal of record, it has been found that the petitioner is working at GSSS Mair, Distt. Hamirpur, H.P w.e.f. 30.09.2023 and under order of transfer to GMS Samvi u/c GSSS Tikkar, Distt. Shimla. At present the post of TGT (NM) is lying vacant at GSSS (B) Kunihar, Distt. Solan. The petitioner has given willingness for her transfer/adjustment at the aforesaid school against vacancy. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetically, and she is hereby transferred/adjusted at GSSS (B) Kunihar, Distt. Solan, without TTA/JT. The representation of the petitioner is disposed of accordingly.
