In the Matter: CWP No.6552/2024 titled as Pooja ,TGT(Med) Vs State of H.P & others

The petitioner Smt.Pooja,TGT(Med) filed CWP No.6552/2024 titled as Smt.Pooja TGT(Med)Vs State of HP before the Hon'ble High Court regarding seeking her transfer from GSSS Kothi (Anni) Distt. Kullu after completion of required tenure as per policy.The case of the petitioner was listed before the Hon'ble High Court on 11-07-2024,when after hearing the matter the Hon'ble High Court disposed of the same with the following direction:-

"Learned counsel appearing of the petitioner submits that with respect to the grievance being raised in the present petition ,an appropriate representation dated 14-03-2024 stands made to the concerned quarters. Representation in this respect made by the petitioner is appended alongwith the present petition as Anneure P-3

Learned Additional Advocate General submits that the representation so made shall be decided within two weeks from today.

In view thereof ,the present petition is disposed of ,so also pending miscellaneous application ,if any."

The petitioner submitted her representation to the undersigned dated 23-07-2024, in which she has requested that she may be adjusted in GSSS Jai Devi/ GSSS Meramasit or GBSSS Sundernagar Distt. Mandi against longer stayee or vacancy.

From the perusal of the record, it reveals that Smt. Pooja ,TGT(Med) is presently working in GSSS Kothi Distt. Kullu since 24th february, 2021.At present there is no vacancy in above said institutions mentioned by the petitioner.As per provision contained in comprehensive guiding Principles-2013 for regulating the transfer of State Government employees.It is specifically mention in para 12.1"**All employees during their entire period of service will serve for at least single tenure in the Tribal /difficult/ Hard areas and remote /rural areas. Transfer to a particular place of choice cannot be claimed as a matter of right.It will be the discretion of the State Government to post/transfer any employee anywhere in the State,keeping in view of the administrative exigencies/convenience.**However,being a Govt. employee and that too in a State cadre request of the petitioner is not tenable and rejected.
