Whereas, Sh. Vivek Katoch, TGT (NM) preferred CWP No. 5401/2024 titled as Vivek Katoch, TGT(NM) Vs. State of H.P. before the Hon'ble High Court of H.P. regarding her transfer from GMS Pujali, U/C GSSS Kalbog, Distt. Shimla, H.P. to nearby home station in Distt. Kangra, H.P. against vacancy or against longer stayee by clubbing his/her previous stay. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 14-06-2024 when the Hon'ble High Court has passed the following orders:-

3. "This writ petition is accordingly disposed of with the direction that the representation made by the petitioner, appended with the writ petition as Annexure P-1, dated 10-05-2024, be decided by the competent Authority, sympathetically, in light of the averments made therein, within a period of six weeks from today. Pending miscellaneous application(s), if any, also stand disposed of accordingly."

In compliance with the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 09-07-2024. He attended the same and submitted his representation in this office, vide which he has requested that he has completed required tenure at his present place of posting and he further requested that he may be transferred to nearby home station in Distt. Kangra, H.P, against vacancy/against longer stayee by clubbing his/her previous stay.

Whereas, from perusal of record, it has been found that the petitioner is working at GMS Pujali, U/C GSSS Kalbog, Distt. Shimla, H.P w.e.f. 23-12-2019 and has completed the normal tenure of three years. One post of TGT(NM) is going to be vacant due to retirement of present incumbent at GMS Bodhal, U/C GSSS Pahra, Distt. Kangra. Keeping in view the above facts and circumstances, the representation of the petitioner is considered sympathetically and he is hereby transferred without TTA/JT from GMS Pujali, U/C GSSS Kalbog, Distt. Shimla, H.P to GMS Bodhal, U/C GSSS Pahra, Distt. Kangra, H.P, against vacancy likely to be caused due to retirement of present incumbent 31.12.2024. These orders will be implemented after the retirement of present incumbent on 31.12.2024. The representation of the petitioner is disposed of accordingly.
