ORDER



In the matter of CWP No. 3787/2024 titled as Sharda Devi and others Vs. State of HP & Anr. (Reg. Pay Scale).

That the petitioners have filed the above titled case before the Hon'ble High

Court of H.P. thereby seeking the following substantive reliefs:-

"(i) That the respondents may very kindly be directed to grant the pay scale as is prescribed to the post of Shastri teacher instead of pay scale as were granted to other similar situated persons in view of judgment passed by the Hon'ble High Court in Madan Lal's case with all consequential benefits and the arrears accrued there under may very kindly be ordered to be released with interest @ 9% per annum in the interest of justice."

The said case was listed before the Hon'ble High Court on 04.07.2024 when

the same was disposed of with the following orders:-

"2. Learned counsel for the petitioners submits that the case of the petitioners is squarely covered by the judgments passed by this Court in CWP No. 3341 of 2019, titled as Madan Lal vs. State of H.P. & Ors and CWPOA No. 6582 of 2019, titled as Prem Sukh vs. State of H.P. & Ors. He further submits that petitioners shall be content in case the respondents are directed to consider the case of the petitioners in a time bound manner in the light of judgments ibid.

3. Prayer being innocuous is not opposed. Accordingly, the instant petition is disposed of without making any comments on the merits of the case of the petitioners. It is directed that respondents shall consider the case of the petitioners in light of judgment passed by this Court in CWP No.3341 of 2019, titled as Madan Lal vs. State of H.P. & Ors and CWPOA No. 6582 of 2019, titled as Prem Sukh vs. State of H.P. & Ors., within eight weeks from today and will decide the same by passing a speaking order. In case petitioners are found similarly situated as petitioners in CWP No. 3341 of 2019, titled as Madan Lal vs. State of H.P. & Ors and CWPOA No.6582 of 2019, titled as Prem Sukh vs. State of H.P. & Ors., they will also be granted the same benefits as granted to petitioners in above referred case. Pending applications, if any, also stand disposed of."

The fact of the matter is that the Govt. of H.P. Finance Department notification dated 23.03.1989 provided the pay scale for Shastries and LTs Rs. 1640-2925 which was effective w.e.f. 01.01.1986 & which was subsequently revised to Rs. 5480-8925 w.e.f. 01.01.1996. But the Dy. Secy. to the Govt. of HP issued executive/administrative instructions dated 21.12.1989 "that the pay scale granted to Shastries and LTs vide notification dated 23.03.1989, Shall be applicable only to those Shastries and LTs who are qualified at par with TGTs. The Shastries and LTs who are not qualified at par with TGTs their pay scale shall be Rs. 1500-2700 which was further revised to Rs. 5000-8100 instead of 5480-8925 w.e.f. 01.01.1996." But the HHC in CWP(T) No. 5759/2008 titled as Subhash Chand had ruled out that the administrative instructions dated 21.12.1989 could not be superseded the statutory rules dated 23.03.1989 framed under Article 309 of the Constitution of India.

The case of the petitioners in nutshell is that the petitioners engaged by the PTAs of concerned schools w.e.f. 29.06.2006 to 31.01.2008 and got fixed emoluments under PTA Grant-In-Aid Rules 2006. Thereafter, the services of the petitioners were converted into contract in January, 2015 and regularized from 01.04.2018 in the pay band of Rs. 10300-34800+Rs. 3200/-(GP), whereas, the petitioner mentioned in CWP No. 3341 of 2019, titled as, Madan Lal vs. State of H.P. & others was appointed against the post of Shastri w.e.f. 27.08.1990 on regular basis and in CWPOA No. 6582 of 2019, titled as, Prem Sukh vs. State of H.P. & others the petitioner was appointed against the post of Shastri w.e.f. 07.07.1997 on regular basis as per R&P Rules 1973.

The R&P Rules in r/o Shastries were repealed on 17.05.2010. The pay scale mentioned in the R&P Rules of Shastries dated 17.05.2010 was 10300+3200 and were framed under article 309 of the Constitution of India. Similarly the R&P Rules in r/o LTs were repealed on 31.12.2009 and the pay scale mentioned therein was 5000-8100 which was revised to 10300+3200(GP) w.e.f. 01.01.2006.

Since the pay scale to the petitioners has been given as per the existing R&P Rules framed under article 309 of the Constitution of India therefore, the petitioners are not similar situated to CWP No. 3341 of 2019, titled as, Madan Lal vs. State of H.P. & others and CWPOA No. 6582 of 2019, titled as, Prem Sukh vs. State of H.P. & others. Hence, the pray of the petitioners are hereby rejected and inform all the concerned accordingly.
