Whereas, Susheel Kumar, TGT (NM) preferred CWP No. 6621/2024 titled as Susheel Kumar, TGT (NM) Vs. State of H.P. before the Hon'ble High Court of H.P regarding his transfer from GSSS Kholanal, Distt. Mandi, H.P to nearby home station in Distt. Mandi and Distt. Hamirpur, H.P. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 12-07-2024, when the Hon'ble High Court has passed the following orders:-

3. "Learned Advocate General submits that as the petitioner has completed 5 years at the present station, therefore, the request of the petitioner will be sympathetically looked into by the Authority conserned within a period of four weeks. His statement is taken on record and respondents are directed to transfer the petitioner out of the station where he is presently posted within a period of four weeks by taking into consideration the request made; if any, by the petitioner for his adjustment at some other station. Pending miscellaneous application(s), if any, also stand disposed of."

In compliance with the aforesaid orders of the Hon'ble High Court the petitioner has submitted his representation in this office on 12-08-2024. He attended the same and submitted his representation in this office on 12-08-2024, vide which he has requested that he may be transferred nearby native place in Distt. Mandi and Distt. Hamirpur, H.P, against vacancy/ longerstay by clubbing his/her previous stay within radius of 30 Kms.

Whereas, from perusal of record, it has been found that the petitioner is working at GSSS Kholanal, Distt. Mandi, H.P w.e.r July, 2019 and has completed the normal tendre of three years at present place of posting. One Sh. Ajay Kumar, TGT(NM) is working in GSSS Gopalpur, Distt. Mandi, H.P since Q8-08-2022. The petitioner has given willingness for his transfer to the aforesaid school against longer stay by clubbing his previous stay within radius of 30 Kms. Keeping in view of the position stated above, the representation of the petitioner is considered sympatheticay, and he is hereby transferred without TTA/JT from GSSS Kholanal Distt. Mandi, H.P to GSSS Gopalpur, Distt. Mandi, H.P. vice Sh. Ajay Kumar, TGT(NM), against longer stay by clubbing his previous stay within radius of 30 Kms., with TTA/JT to Sh. Ajay Kumar, TGT(NM). The representation of the petitioner is disposed of accordingly.
