ORDER

In the matter : CWP No. 7077/2024 titled as Smt. Shalini Sisodia, TGT(Med) VS State of H.P. & others.

The Petitioner, Smt. Shalini Sisodia, TGT (Med), filed CWP No. 7077/2024 titled as Shalini Sisodia, Vs State of H.P. before the Hon'ble High Court of H.P. regarding aggrieved her transfer from GSSS Averi(KGR) to GSSS Chobia (CBA). The case of the petitioner was listed before the Hon'ble High Court, Shimla-2 on 22nd July, 2024, when after hearing the matter, the Hon'ble High Court has disposed of the same with the following directions/ order:-

"As prayed for, this writ petition is disposed of with direction that let the petitioner file a representation for her adjustment within a period of one week from today, mentioning therein the details of the stations where vacancy is available and as from the date of receipt thereof, let in appropriate order be passed thereupon by the competent Authority, sympathetically, within a period of four weeks, taking into consideration the ailments of her husband. Till decision of the representation, the petitioner shall not be forced to join at GSSS Chobia (Bharmour) and she may avail the kind of leave due to her. Pending miscellaneous application(s), if any also stand disposed of accordingly. "

As per direction of the Hon'ble High Court the petitioner was called for personal hearing on dated 12-08-2024. The petitioner attended the personal hearing on scheduled date and time. During personal hearing the petitioner has requested that she may be adjusted at GSSS Kandbari/GSSS Bindraban /GSSS Dehan/GSSS Saliyana and GSSSS Palampur Distt. Kangra against longer stay or by clubbing previous stay. The petitioner has further stated that her husband is suffering from kidney problem. As such there is no one of the family to look after him.

From the perusal of the record, it reveals that Shalini Sisodia, TGT(Med) is presently w/t from GSSS Averi (KGR) to GSSS Chobia Distt. Chamba in view of CWP No.2734/2024 titled as Smt. Monika Katna, TGT(Med). As per averments made by the petitioner the representation is considered sympathetically and she is hereby adjusted in GSSS, Kachhiari distt. (kangra) against vacancy likely to be caused due to retirement of the present incumbent i.e. Smt. Benu Parban, TGT (Med). With these observations the representation of the petitioner is considered and disposed of accordingly.
