Therefore, after careful examination, it is decided that since the Department of Higher Education is going to make promotions to the post of School Lecturer (New) from amongst the eligible Trained Graduate Teachers in near future, hence the petitioner will be given posting at a suitable place as and when the vacancy will arise at her place of choice in Distt. Una, H.P.The representation of the petitioner is disposed of accordingly.
