## OFFICE ORDER

The petitioner filed one CWP No. 3283/2024 which was treated as representation vide order dated 23.04.224 and as per the representation of the petitioner it was found that mid academic session and as he was the sole Science teacher at GMS Khajua Bihali u/c GSSS Ganed, Distt. Chamba with as enrolment of 81 students. If he was shifted from the school then there would have been no teacher to teach Science to the students. The petitioner could not be adjusted against the stations mentioned by him since out of five stations mentioned by him, at one station there was a handicapped incumbent and at the second station the incumbent has already served at hard area. Moreover Sh. Vivek Sharma, TGT (NM) is working in GMS Bardi u/c GSSS Aund since 06.10.2023, Sh. Rajesh Kumar, TGT (NM) is working in GMS Malhanta u/c GSSS Diana since 19.01.2022 and Sh. Rakesh Kumar is working in GHS Kolhari u/c GSSS Dhameta, Distt. Kangra since 11.11.2021 and had not completed their normal tenure, hence, the representation of the petitioner was rejected.

However, in compliance to the directions of this Hon'ble Court in CWP No. 9219/2024, dated 03-09-2024 titled as Raman Kumar vs State of H.P, the order dated 04.07.2024 placed as Annexure P-5 hereby reviewed. Now, as per the representation of the petitioner, Sh. Raman Kumar, TGT(NM) is hereby transferred/adjusted without TT/JT from GMS Khajua Bihali, U/C GSSS Ganed, Distt. Chamba, H.P. to GHS Kolhari, U/C GSSS Dhameta, Distt. Kangra, H.P vice Sh. Rakesh Kumar, TGT(NM) & vice-versa, with TTA/JT to Sh. Rakesh Kumar, TGT(NM).
