The Operative portion of the present CWP judgement is as under:-

"In view of the request so made by learned cousel for the petitioner, this petition is disposed of without interfering with the transfer order, but with the observation that if the petitioner files any representation for his adjustment at some other station, same be considered sympathetically within a period of two weeks keeping in view the fact that his is a couple case. Till then, the petitioner shall not be forced to join at at the station to which he stands transferred and he can avail the kind of leave due to him." Pending miscellaneous application(S), if any, shall also stand disposed of.

In compliance to the aforesaid orders passed by the Hon'ble High Court of Himachal Pradesh, the petitioner i.e Sh. Vishal Singh Ranout, TGT (Med.) has submitted fresh representation stated that he is under transfer from GSSS, Dumehar Distt. Bailspur to GSSS, Mailan distt. Shimla which is far away from his home town and on the ground of couple case as per provision in clause 5.4 of Comprehensive Guiding Principles 2013 adjust him at GSSS, Tarseoh Distt. Bilaspur.

Keeping in view the above provision of transfer policy, the representation of the petitioner is considered sympathetically and he is hereby adusted at GSSS. Tarsooh Distt. (Blp.) against vacancy, being a couple case without TTA/JT. With these observation the representation of the petitioner is disposed of. All the concerned be intimated accordingly.
