Whereas, Harjinder Singh Rana, TGT (NM) preferred CWP No. 7307/2024 titled as Harjinder Singh Rana, TGT (NM) Vs. State of H.P. before the Hon'ble High Court of H.P regarding his transfer from GSSS Swar, Distt. Mandi, H.P to nearby home station in Distt. Mandi, H.P. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 29-07-2024, when the Hon'ble High Court has passed the following orders:-

3. "This writ petition is accordingly disposed of with the direction that the representation filed by the petitioner be decided in light of the averments made therein within a period of six weeks from today. Pending miscellaneous application(s), if any, also stand disposed of accordingly."

In compliance with the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 10-09-2024. He attended the same and submitted his representation in this office on 10-09-2024, vide which he has requested that he may be transferred from GSSS Swar, Distt. Mandi (falls in sub cadre area of Chauhar Valley) to nearby native place in Distt. Mandi, H.P, against vacancy/ longer stay by clubbing his/her previous stay radius of 30 Kms. .

Whereas, from perusal of record, it has been found that the petitioner is working at GSSS Swar, Distt. Mandi (falls in sub cadre area of Chauhar Valley) w.e.r 23-11-2021 and has almost completed the normal tenure of three years at present place of posting. One Sh. Puneet Kashyap, TGT(NM) is working in GMS Janed, U/C GSSS Randhara, Distt. Mandi, H.P since 22-09-2022. The petitioner has given willingness for his transfer to the aforesaid school against longer stay by clubbing his/her previous stay within radius of 30 Kms. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetically and he is hereby transferred without TTA/JT from GSSS Swar, Distt. Mandi to GMS Janed, U/C GSSS Randhara, Distt. Mandi, H.P vice Sh. Puneet Kashyap, TGT(N.M), against longer stay by clubbing his previous stay within radius of 30 Kms., with TTA/JT to Sh. Puneet Kashyap, TGT(NM) . The representation of the petitioner is disposed of accordingly.

In the matter of: CWP No. 7421/2024 titled as Rajmal Chauhan, TGT (NM) Vs. State of H.P. & ors.

Whereas, Sh. Rajmal Chauhan, TGT (NM) who is u/t from GMS Sarli u/c GSSS Panjain, Distt. Mandi to GSSS Kedi, Distt. Shimla has filed CWP No. 7421/2024 titled as Rajmal Chauhan, TGT (NM) Vs. State of H.P. before the Hon'ble High Court of H.P regarding his transfer/adjustment in Distt. Mandi/Kullu against vacancy. The above writ petition was listed before the Hon'ble High Court Himachal Pradesh on 30.07.2024 when the Hon'ble High Court has passed the following orders:-

"6. Taking into consideration the prayer of the petitioner, this petition is disposed of without expressing any opinion on the legality of the impugned transfer order by ordering that the impugned transfer order dated 25.07.2024 shall not implemented for a period of three weeks from today. However, this will be subject to the condition that the petitioner will have to make a representation for his adjustment at some other station, within a period of one week from today and appropriate order thereupon be passed by the authority, within a period of two weeks as from the date of receipt thereof, by passing a speaking order.

7. This Court again observes that it has not expressed any opinion on the merit of the case. Till the decision of the representation of the petitioner, he be allowed to serve at his present place of posting. Pending miscellaneous application(s), if any, stand disposed of accordingly."

In compliance of the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 10.09.2024. He has attended the same and submitted his representation in this office on 10.09.2024 vide which he has requested that he has not completed his normal tenure at his present place of posting i.e GMS Sarli u/c GSSS Panjain, Distt. Mandi, H.P and he further requested that he may be transferred/adjusted at GSSS DK Chong, GMS Sarahan u/c GSSS Deori, GMS Narwali u/c GSSS Shanghar, GMS Neuli u/c GSSS Shanghar, Distt. Kullu, against vacancy or GMS Jhiri u/c GSSS Nagwain, Distt. Mandi against longer stayee.

Whereas, from perusal of record, it has been found that the petitioner is working at GMS Sarli u/c GSSS Panjain, Distt. Mandi, H.P w.e.f. 11.10.2022 and under order of transfer to GSSS Kedi, Distt. Shimla. At present the post of TGT (NM) is lying vacant at GMS Neuli u/c GSSS Shanghar, Distt. Kullu. The petitioner has given willingness for his transfer/adjustment at the aforesaid school against vacancy. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetically, and he is hereby transferred/adjusted at GMS Neuli u/c GSSS Shanghar, Distt. Kullu, without TTA/JT. The representation of the petitioner is disposed of accordingly.
