ORDER

In the matter of:

CWP No: .6917/2024-Dharam Singh V/s. State of Himachal Pradesh.

The petitioner has filed CWP No. 6917/2024 titled as Dharam Singh V/s State of H.P. in the Hon'ble High Court and seeking his transfer from GMS Rulang u/c GSSS Barot (MND) to station mentioned in representation against vacancy or longer stayee. The case was listed before the Hon'ble High Court of H.P. on 18-07-2024, on this day Hon'ble Court has passed order/judgment. The Operative portion of the present CWP judgement is as under:-

"Learned Counsel for the petitioner submits that the petitioner has filed a representation with regard to the issu raised in the petition, but the same has not been decided by the Authority concerned till date.

This petition, accordingly, as prayed for, is disposed of with the direction that let representation of the petitioner be dicided, in the light of the averments made therein as well as the judgment being relied upon by the petitioner, within a period of four weeks, by the Competent authority. Pending miscellaneous applications, if any also stand disposed of."

In compliance to the aforesaid orders passed by the Hon'ble High Court of Himachal Pradesh, the petitioner i.e Sh. Dharam Singh, TGT (Arts) has attended the personal hearing on 23-08-2024 and has stated/represented that he has completed normal tenure at his present place of posting (Sub cadre) so that requested for transfer from GMS Rulang u/c GSSS Barot Distt. Mandi either to GMS Kasoun u/c GSSS Dhar (MND) against vacancy due to retirement of present incumbent on October, 2024, GSSS Sarounjh, GSSS Urla, GSSS Garlog, GSSS Sahal, Distt. Mandi, against vacancy or longer stayee.

From the perusal of record, it is found that Sh. Dharam Singh, TGT (Arts) is working at GMS Rulang u/c GSSS Barot Distt. Mandi since 09.8.2021 and has completed normal tenure at his present place of posting. One post of TGT (Arts) is going to be vacant at GMS Kasoun u/c GSSS Dhar (MND) due to retirement of present incumbent on 31-10-2024. Therefore, after thorough examination and thoughtful application of mind the request made by the petitioner in his representation is considered sympathetically and he is hereby transferred/adjusted at GMS Kasoun u/c GSSS Dhar, Distt. Mandi against vacancy, being caused due to the retirement of present incumbent, without TTA/JT. The petitioner will join after superannuation of present incumbent i.e. after 31.10.2024. The representation of the petitioner is disposed of accordingly.
