"In this view of the matter, as prayed for, without interfering with the impugned transfer order, the writ petition is disposed of with liberty to the petitioner to make an appropriate representation to the authority for her adjustment at some nearby station, being a couple case and in the event of any such representation being filed by the petitioner within a period of one week from today, let a call be taken thereupon in terms of the policy sympathetically within a period of two weeks as from the date of the receipt thereof. Till the decision thereof, the petitioner be not forced to join the station, to which, she stands transferred and she shall be at liberty to avail the leave of the kind due to her. Pending miscellaneous applications, if any, also stand disposed of."

In compliance to the aforesaid orders passed by the Hon'ble High Court of Himachal Pradesh, the petitioner i.e Smt. Surjit Kaur, TGT (Arts) has attended the personal hearing on 10-09-2024 and has submitted representation, wherein requested to adjust her at GSSS Thana, District Solan, against vacancy, being a couple case, because her husband is working as TGT (NM).

From the perusal of record, it is revealed that Smt. Surjit Kaur, TGT (Arts) was transferred from GSSS Behal District Bilaspur to GHS Sarma u/c GSSS Bani Materni District Solan against vacancy, after completion of normal tenure. At present one posts of TGT (Arts) is lying vacant in GSSS Thana, District Solan.

Keeping in view the position stated above, representation of petitioner i.e Smt. Surjit Kaur, TGT (Arts) is considered sympathetically, as per provision in Clause 5.4 of Comprehensive Guiding Principles 2013, the petitioner Smt. Surjit Kaur, TGT (Arts) is hereby adjusted at GSSS Thana District Solan against vacancy, being a couple case, without TTA/JT. The representation of the petitioner is disposed of accordingly.
