Whereas, Sh. Sandeep Kumar, TGT (NM) preferred CWP No. 8237/2024- titled as Sandeep Kumar Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GMS Lag, U/C GSSS Bathra, Distt. Kangra, H.P to GHS Kharapathar, U/C GSSS Jubbal, Distt. Shimla, H.P. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 13-08-2024 when the Hon'ble High Court has passed the following order

*"2. When his case was taken up for consideration, learned counsel for the petitioner submitted that he has instructions to withdraw this writ petition as the petitioner intened to file a representation for his adjustment at some other station. The petition is accordingly permitted to be withdrawn. Pending miscellaneous application(s), if any, also stand disposed of accordingly."*

In the compliance of the aforesaid orders passed by the Hon'ble High Court, the petitioner was called for personal hearing on 10-09-2024. He attended the same and submitted his representation in this office on 10-09-2024, vide which he has requested that he may be transferred/ adjusted at nearby native place in Distt. Kangra, H.P, against vacancy/ longer stay by clubbing his/her previous stay radius of 30 Kms. on medical grounds.

From perusal of record, it has been found that the petitioner has been transferred from GMS Lag, U/C GSSS Bathra, Distt. Kangra, H.P to GHS Kharapathar, U/C GSSS Jubbal, Distt. Shimla, H.P. The petitioner has given willingness for his adjustment to the aforesaid school against longer stay by clubbing his/her previous stay within radius of 30 Kms. At present there is no post of TGT(NM) are lying vacant in the schools mentioned by the petitioner in his representation. One Sh. Arvind Kumar, TGT(NM) is working in GMS Bara, U/C GSSS Sunhet Distt. Kangra since 04-08-2021 and has completed more than three years stay there. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetically, and he is hereby adjusted, without TTA/JT at GMS Bara, U/C GSSS Sunhet, Distt. Kangra vice Sh. Arvind Kumar, TGT(NM) and he is further transferred to GSSS Mangli, Distt. Chamba, H.P, against vacancy, with TTA/JT. The representation of the petitioner is disposed of accordingly.
