In the matter of: CWP No. 9730/2024 titled as Suresh Kumar, TGT (NM) Vs. State of H.P & ors.

Whereas, Sh. Suresh Kumar, TGT (NM) who is u/t due to merger (GMS) having student enrolment of less than or equal to five (5) from GMS Diara u/c GSSS Gharoh, Distt. Kangra to GSSS Bharara, Distt. Chamba has filed CWP No. 9730/2024 titled as Suresh Kumar, TGT (NM) Vs. State of H.P. before the Hon'ble High Court of H.P regarding his transfer/adjustment in GSSS Boh, Distt. Kangra due to larger enrollment of student alongwith post. The above writ petition was listed before the Hon'ble High Court Himachal Pradesh on 10.09.2024 when the Hon'ble High Court has passed the following orders:-

"6. Learned Additional Advocate General submits that if the petitioner makes a representation pointing out five stations of his choice within a period of one week from today, then the same shall be considered by the competent authority in accordance with law within two weeks' thereafter.

7. The impugned transfer order dated 06.09.2024 (Annexure P-4) insofar as, it pertains to the petitioner, shall remain stayed till disposal of the representation by the competent authority. The writ petition stands disposed of in the above terms, so also the pending miscellaneous application(s), if any.

In compliance of the aforesaid orders of the Hon'ble High Court the petitioner submitted his representation in this office on 13.09.2024 vide which he has requested that he may be transferred/adjusted in GSSS Boh, Distt. Kangra due to larger enrollment of student alongwith post.

Whereas, from perusal of record, it has been found that the petitioner is working at GMS Diara u/c GSSS Gharoh, Distt. Kangra who is under order of transfer/adjusted to GSSS Bharara, Distt. Chamba, due to merger (GMS) having student enrolment of less than or equal to five (5), GSSS Bharara, Distt. Chamba falls in sub-cadre area the petitioner has already served in sub-cadre area. At present (202 students) larger enrolment of students in GSSS Boh, Distt. Kangra, and only one TGT (NM) is working there. The petitioner has given willingness for his transfer/adjustment at the aforesaid school alongwith post. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetically, and he is hereby transferred/adjusted at GSSS Boh, alongwith post, Distt. Kangra, without TTA/JT. The representation of the petitioner is disposed of accordingly.
