

The National Commission for Protection of Child Rights (NCPCR) (hereinafter referred to as 'the Commission') is a statutory body constituted under Section 3 of the Commission for Protection of Child Rights (CPCR) Act, 2005 to protect the rights of children and address other related matters in the Country. The Commission is further mandated to monitor the proper and effective implementation of Protection of Children from Sexual Offences (POCSO) Act, 2012; Juvenile Justice (Care and Protection of Children) Act, 2015 and Right to Free and Compulsory Education (RTE) Act, 2009. One of the functions of the Commission under Section 13(1) (h) of the CPCR Act, 2005 is to spread child rights literacy among various sections of the society and promote awareness of the safeguards available for protection of these rights through publications, the media, seminars and other available means.

2. In the light of its mandate and responsibilities, the Commission has been conducting inspection visits, grievance redressal camps/benches and consultation programmes at district as well as State-level. It was observed during these activities that the beneficiaries under the Act as well as the Authorities responsible for its implementation are not fully aware of the information pertaining to the provisions for the Act. Therefore, the Commission has developed Information Education Communication (IEC) material in form of short videos on different provisions under the Right to Education Act, 2009. The videos are available on NCPCR's YouTube channel at <https://www.youtube.com/@NCPCR/videos>.

5. The awareness of all stakeholders is crucial for effective implementation of the Act. Therefore, it is requested to ensure that the videos are circulated among all the stakeholders including the SMCs.
