In the matter of CWP No. 3900 of 2024 - Sheela Machhartell-1 & Others Vs. State of H.P. & others decided on 09.05.2024.

ORDER.

Whereas, Smt. Sheela Machhan & Others have filed the CWP No. 3900/2024 titled as Smt. Sheela Machhan & Others vs State of H.P. & ors. in the Hon'ble High Court of H.P. whereof the operative part of the judgment is as under:

2. The petitions are disposed of without making any comments on the merits of the case of the petitioners. It is directed that respondents shall consider the case of the petitioners in light of judgment passed by this Court in CWP No. 5043 of 2022, titled as, Sunita Sangroli vs. State of H.P. & others on 8.8.2023, within eight weeks from today and will decide the same by passing a speaking order. In case, the petitioners are found similarly situated as petitioner in above mentioned judgment, they will also be granted the same benefits as granted to petitioner in above referred case. Pending miscellaneous application, if any, also stand disposed of.

Whereas, after perusal of record it is found that contract appointments were made in the Education Department as per Government policy dated 23.08.1994 and later on their services were regularized after 08 years of continuous service as per Government approval. But some of contractual employees were retrenched due to joining of regular hand hence junior contractual employees were regularized in the department earlier and senior later as "last come first go" Principle was not followed while terminating their contract service. Such retrenches either were re-engaged in the department on contract basis or they were given preference order Para Teacher Policy notified by the Government in the year 2003 and they were hired under Para Teacher policy and regularized after completion of 10 years of continuous service in the year 2014 and 2015.

And whereas, Petitioners were also the retrenched contractual TGTs who were initially engaged on contract basis from the year 1996 to 1999 and whose services were terminated due to joining of regular teachers. Later on they were also hired/engaged as TGT(Arts) under Para Teacher Policy,2003. The Department has allowed the benefit of regularization to those

contractual TGTs whose services were terminated due to joining of regular teacher and who were later on hired under Para Teacher Policy, 2003 vide office order No. EDN-H(2)B(2)35/20241-Para Teacher dated 23.02.2022, 30.08.2022, 14.03.2024 and 19.03.2024 by condoning their break period from the date when the services of their counterparts were regularized i.e. w.e.f. 20.12.1988, 01.01.2005, 01.01.2006, 01.01.2007, 20.12.2008.

Whereas, Smt. Sunita Sangroli in CWP No. 5043/22 was appointed as a temporary measure on "Contract Basis" and joined on 01.07.1997. Her services were terminated on 31.12.98 due to joining of regular incumbent. Her services were regularized by the Department vide office order dated 27.07.2010. Thereafter her services were re-engaged again on contract basis and she joined as such on 10.12.2001. Thereafter, the services of Smt. Sunita Sangroli lecturer, History is hereby regularized w.e.f. 01.01.2006 instead of 27.07.2010 by considering the initial contract engagement with all consequential benefits.

Whereas Smt. Sunita Sangroli has filed CWP No. 5043/2022 in the Hon'ble High Court sought relief thereby all consequential benefits, the operative part of the judgment in reproduced benefits are below

13. In result, the petition is allowed. Office memorandum dated 06.07.2020 (Annexure P-7), is quashed and set aside. Respondents are directed to grant benefit of earned leave to the petitioner from the initial date of contract appointment i.e. 25.06.1997 within eight weeks from today.

Hence, in view of the facts and as directed vide letter No. EDUC-E05/25/2024 dated 27.09.2024 that such similar situated cases may be decided by Department at their own level, as per the directions conveyed to Director of Higher Education vide letter No. letter No. EDN-B-E(3)-4/2024, dated 01.08.2024 in compliance of CWP No. 5043 of 2022 titled as Sunita Sangroli vs State of HP & others and whereas the Govt. has directed to implement the order of Hon'ble High Court and credit the earned leave in the account of petitioners i.e. Sheela Machhan & Others (in CWP No. 3900/2024) along with other similarly situated petitioners with effect from initial date of their regularization without any financial benefits.

Therefore the petitioners in the present petitioners (Sheela Machhan & Others in CWP No. 3900/2024) are similarly situated to Smt. Sunita Sangroli (CWP No. 5043/2022) and hence entitled for the same benefits which was released to Smt. Sunita Sangroli from initial date of regularization without any financial benefits.
