**ORDER**

In the matter of: CWP No. 2292/2024-titled as Sunil Kumar Dogra (TGT Med.) V/s State of Himachal Pradesh and others (Regarding Transfer).

Sh. Sunil Kumar Dogra, TGT (Med.) has filed CWP No. 2292/2024 titled as Sunil Kumar Dogra V/s State of H.P. in the Hon'ble High Court, and seeking his transfer from GSSS, Naraingarh Distt. Mandi (Sub cadre/hard area) District Mandi either to GSSS, Banoli (Kgr.) GSSS, Bharmad (Kgr.), GSSS, Dah Khulara District Kangra vice versa basis by clubbing their stay within the radius. The case was listed before the Hon'ble High Court of H.P. on 10.09.2024, on this day Hon'ble Court has passed order/judgment. The Operative portion of the present CWP judgement is as under:-

"Learned Counsel Advocate General has placed on record communication dated 24.04.2024, copy whereof, has been supplied to learned counsel for the petitioner. The same reflects the three vacant stations where the petitioner can be posted.

Learned counsel for the petitioner, under instructions, submits that the petitioner is ready and willing to join at Government Senior Secondary School, Bathri, district Chamba, H.P.

In view of the above submissions, present petition stands disposed of, so also, the pending miscellaneous application(S), if any.

In compliance to the aforesaid orders passed by the Hon'ble High Court of Himachal Pradesh, the petitioner i.e Sh. Sunil Kumar Dogra, TGT (Med.) has submitted fresh representation and stated that he has completed normal tenure at his present place of posting in sub cadre/hard area and has requested for transfer either to GSSS, Bathri Distt. Chamba a/v. or GSSS, Banoli (Kgr.) GSSS, Bharmad (Kgr.) And GSSS, Dah Kulara Distt.(Kgr.)on vice-versa basis.

From the perusal of record, it is found that Sh. Sunil Kumar Dogra, TGT (Med.) is working at GSSS, Naraingarh (Sub cadre/hard area) District Mandi since 02.12.2019 and has completed normal tenure at his present place of posting. At present post of TGT (Med.) is not lying vacant in GSSS, Bathri District Chamba. However, one Sh. Vikas Choudhary, TGT (Med) is working in GSSS, Banoli Distt. Kangra since 22.07.2022 and having short stay, but serving within the radius of 30 Km. (Aprx.) since 2014. The continuous services rendered by employees of Education Department within a radius of 30 Km. be considered stay/tenure at one station & such services will be clubbed for calculation of tenure purpose of transfers.

Keeping in view the position stated above, representation of petitioner is considered sympathetically and he is hereby transferred from GSSS, Naraingarh District Mandi to GSSS, Banoli District Kangra vice Sh. Vikas Choudhary, TGT (Med.) and vice versa by clubbing his previous tenure (with TTA/JT) to Sh. Vikas Choudhary. Keeping in view the position stated above, representation of the petitioner i.e Sh. Sunil Kumar Dogra, TGT (Med.) is disposed of accordingly.
