Whereas, Smt. Renu Bala, TGT (NM) preferred CWP No. 9783/2024 titled as Renu Bala, Vs. State of H.P. before the Hon'ble High Court of H.P. regarding her transfer from GSSS Khargat, Distt. Chamba, H.P to nearby station at her native place in Distt. Kangra, H.P. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 11-09-2024 when the Hon'ble High Court has passed the following orders:-

"3. As prayed for, this petition is disposed of with the direction that let the case of the petitioner for her transfer and her representation, be decided by the Authority concerned but at he time when general transfers are effected by the Department of Education. In orther words, misacademic transfer shall not be effected but her case shall sympathetically e considered, in the light of the contents of the representation, when general transfer are ordered by teh Department. Pending miscellaneous application(s), if any, also stand disposed of accordingly."

In compliance with the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 04-10-2024. She attended the same and submitted her representation in this office on 04-10-2024, vide which She has requested that She may be transfer from GSSS Khargat, Distt. Chamba, H.P to nearby station at her native place in Distt. Kangra, H.P, against vacancy/ against longer stay by clubbing his/her previous stay radius of 30 Kms. At present there is no vacancy of TGT(NM) in District Kangra, H.P.

From perusal of record, it has been found that the petitioner has been working at GSSS Khargat , Distt. Chamba, H.P w.e.f 29-07-2022 and has not completed her normal tenure at present place of posting. At present (160) students are studying in GSSS Khargat, Distt. Chamba, H.P and at present post of TGT(NM) is not lying vacant at the schools given by the petitioner. As per provision contained in comprehensive guidelines Principles-2013 for regulating the transfer of State Government employees, it is specifically mentionedin pera 12.1 "All employees during their period of service will serve for at least single tenure in the Tribal/Hard area and remote/rural areas. Transfer to a particular place of choice cannot be claimed as a matter of right. It will be the discretion of the State Govt., to post/transfer any employee anywhere in the State, Keeping in view of the administrative exigencies/ convenience" Therefore, after critical examination and thoughtful application of mind the request made by the petitioner is hereby rejected. The representation of the petitioner is disposed of accordingly.
