ORDER

In the matter of: CWP No. 10810/2024-titled as Neena Puri V/s State
of Himachal Pradesh and others (Regarding Transfer).

Smt. Neena Puri. TGT (Med.) has filed CWP No. 10810/2024 titled as Neena Puri V/s State of H.P. in the Hon'ble High Court. regarding her transfer from GHS, Fatehwal Distt. (Una.) to GSSS, Jamniwala Distt. Sirmour. The case was listed before the Hon'ble High Court of H.P. on 24.09.2024. on this day Hon'ble Court has passed order/judgment. The Operative portion of the present CWP judgement is as under:-

"Learned counsel appearing on behalf of the petitioner submits that with respect to the grievances being raised in the present petition. an appropriate representation shall be made to the concerned authority.

On receipt of the same. the same be decided within a period of three weeks thereafter. In view thereof. the present petition is disposed of. so also. pending miscellaneous application. if any.

In compliance to the aforesaid orders passed by the Hon'ble High Court of Himachal Pradesh. the petitioner i.e Smt. Neena Puri. TGT (Med.) has submitted fresh representation stated that she is under transfer from GHS, Fatehwal Distt. Una to GSSS, Jamniwala Distt. Sirmour which is far away from her home town and her father is of 75 years of age and is suffering from paralysis disease and there is no one to look after his ailing father. So she has requested to adjust her either to GSSS, Dulehar Distt. Una, a/v. and against the longer stayee of TGT (Med.) at GSSS, Sasan Distt. (Una), GSSS, Takka (Una.) and GSSS, Bathu (Una.) H.P.

Keeping in view the position stated above. representation of the petitioner i.e Smt. Neena Puri. TGT (Med.) is considered sympathetically and petitioner is hereby adjusted at GSSS, Dulehar District Una against study leave

vacancy, without TTA/JT. The representation of the petitioner is disposed of accordingly.
