OFFICE ORDER

The COPC No..../2025 in CWP No. 852/2025 titled as Pankaj Kumar Vs State of H.P. & Ors. was listed before the Hon'ble High Court on 10.01.2025, when the Hon'ble High Court disposed of the said writ petition by directing the respondent to consider and decide the representation of the petitioner.

That in pursuance to the directions issued by the Hon'ble High Court dated 10.01.2025 the petitioner Sh. Pankaj Kumar (JBT) represented to transfer him from GPS Sheelghat, EB Dhundhan, Distt. Solan, to GPS Dari, EB Dharamshala, Distt. Kangra against vacancy, under 5% quota.

On perusal of comments/proposal received from Deputy Director Elementary Education Solan, it reveals that the petitioner Sh. Pankaj Kumar, JBT has been working at GPS Sheelghat, E/B Dhundhan, Distt. Solan since 05.10.2019 (on contract basis) and regularized on 08.04.2022, he is permanent resident of Distt. Kangra. He has completed his normal tenure in Distt. Solan under 5% inter distt. transfer policy.

In view of above facts, the representation of the petitioner is examined sympathically after due consideration. Therefore, the Deputy Director of Elementary Education Solan is hereby directed that the petitioner Sh. Pankaj Kumar, JBT may be transferred under 5% inter distt. transfer policy from GPS Sheelghat, EB Dhundhan, Distt. Solan to GPS Dari, EB Dharamshala, Distt. Kangra and a teacher be appointed/posted in GPS Sheelghat through rationalization from a nearby school, so that the school does not remain as without teacher. The teacher will be relieved only after his substitute is provided in the school. The representation stands decided & disposed off accordingly.
