OFFICE ORDER

The CWP No. 3657/2024 titled as Sonu Ram Vs State of H.P. & Ors. was listed before the Hon'ble High Court on 17.03.2025, when the Hon'ble High Court disposed of the said writ petition by directing the respondent to consider and decide the representation of the petitioner.

That in pursuance to the directions issued by the Hon'ble High Court dated 17.03.2025 the petitioner Sh. Sonu Ram (JBT), appeared before the undersigned on dated 22.03.2025 and was heard at length. At the time of personal hearing the petitioner Sh. Sonu Ram, JBT GPS Gochar, EB Jhandutta, Distt. Bilaspur, Himachal Pradesh requested for his transfer under 5% quota from Distt. Bilaspur to Distt. Kangra against vacancy.

On perusal of comments/proposal received from Deputy Director Elementary Education Bilaspur, it reveals that the petitioner Sh. Sonu Ram, JBT has been working at GPS Gochar, E/B Jhandutta, Distt. Bilaspur since 18.06.2019 (on contract basis) and regularized on 13.01.2022, he is permanent resident of Distt. Kangra. He has completed his normal tenure in Distt. Bilaspur under 5% inter distt. transfer policy.

In view of above facts, the representation of the petitioner is examined sympathically after due consideration. Therefore, the Deputy Director of Elementary Education Bilaspur is hereby directed that the petitioner Sh. Sonu Ram, JBT may be transferred under 5% inter distt. transfer policy from GPS Gochar, EB Jhandutta, Distt. Bilaspur to Distt. Kangra and a teacher be appointed/posted in GPS Gochar through rationalization from a nearby school, so that the school does not remain as without teacher. The teacher will be relieved only after his substitute is provided in the school. The representation stands decided & disposed off accordingly.
