In the matter of: CWP No. 3009/2025 -titled as Balbir Singh, Vs. State of H.P. & others.

Whereas, Sh. Balbir Singh, TGT (NM) preferred in CWP No. 3009/2025 titled as Balbir Singh, TGT (NM) Vs. State of H.P. before the Hon'ble High Court of H.P regarding his transfer from GMS Kurthal, U/C GSSS Kiri, Distt. Chamba, H.P (Hard Area) to nearby home station (Soft Area) in Distt. Kangra, H.P. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 04-03-2025, when the Hon'ble High Court has passed the following orders:-

3. "Consequently, in view of above, this court, without going into the merits of the case, deems it fit to dispose of the present petition, with a direction to the respondents to consider and decide the pending representation dated 31-12-2024 and 13-01-2025 filed by the petitioner expeditiously, preferably within a period of four weeks from today. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass speaking order thereupon taking note of provision contained in the transfer policy. Pending applications, if any, stand disposed of."

In compliance with the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 22-03-2025. He attended the same and submitted his representation in this office, vide which he has requested that he has completed required tenure at his present place of posting at GMS Kurthal, U/C GSSS Kiri, Distt. Chamba, H.P and he may be transferred to nearby native place in Distt. Kangra, H.P, against vacancy/ longer stay by clubbing his/her previous stay radius of 30 Kms. .

Whereas, from perusal of record, it has been found that the petitioner is working at GMS Kurthal, U/C GSSS Kiri, Distt. Chamba, H.P since, 26-02-2022 which is a hard area and has completed his normal tenure of three years at his present place of posting. One Sh. Piara Lal, TGT(NM) is working in GSSS Sukhar, Distt. Kangra, H.P. since 29-02-2024. The petitioner has given willingness for his transfer to the aforesaid school against longer stay by clubbing his/her previous stay within radius of 30 Kms. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetic, and he is hereby transferred without TTA/JT from GMS Kurthal, U/C GSSS Kiri, Distt. Chamba, H.P to GSSS Sukhar, Distt. Kangra, H.P. vice Sh. Piara Lal, TGT(NM), against longer stay by clubbing his previous stay within radius of 30 Kms., with TTA/JT to Sh. Piara Lal, TGT(NM). The representation of the petitioner is disposed of accordingly.
