Whereas, Smt. Neha Dhiman, TGT (NM) preferred in CWP No. 2913/2025 titled as Neha Dhiman, TGT (NM) Vs. State of H.P. before the Hon'ble High Court of H.P. regarding her transfer from GSSS Gaonsari, Distt. Shimla, H.P to nearby home station in Distt. Hamirpur, H.P. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 03-03-2025, when the Hon'ble High Court has passed the following orders:-

3. "Consequently, in view of the above, this Court without going into the merits of the case desms, it fit to dispose of the present petition, with a direction to the respondents to consider and decide the pending representation dated 10-10-2024 and 26-12-2024 filed by the petitioner expeditiously, preferably within a period of four week from today. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an apportunity of being heard to the petitioner and pass soeaking order thereupon taking note of provisions contained in the transfer policy. Pending applications, if any, also stand disposed of."

In compliance with the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 24-03-2025. She attended the same and submitted her representation in this office, vide which She has requested that She has completed required tenure at her present place of posting at GSSS gaonsari, Distt. Shimla, H.P and She may be transferred to nearby native place in Distt. Hamirpur, H.P, against vacancy/ longer stay by chibbing his/her previous stay radius of 30 Kms.

Whereas, from perusal of record, it has been found that the petitioner is working at GSSS Gaonsari, Distt. Shimla, H.P. since, 26-02-2022 which is a hard area and has completed her normal tenure at her present place of posting. One Smt. Babita Chandel, TGT(NM) is working in GHS Salouni, Distt. Hamirpur, H.P. since 30-06-2021. The petitioner has given willingness for her transfer to the aforesaid school against longer stay by clubbing his/her previous stay within radius of 30 Kms. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetically, and She is hereby transferred without TTA/JT from GSSS Gaonsari, Distt. Shimla, H.P. to GHS Salouni, Distt. Hamirpur, vice Smt. Babita Chandel, TGT(NM), against longer stay. With TTA/JT to Smt. Babita Chandel, TGT(NM). The representation of the petitioner is disposed of accordingly.
