Whereas, Sh. Manoj Kumar, TGT (NM) preferred CWP No. 3227/2025 titled as Manoj Kumar Vs. State of H.P. before the Hon'ble High Court of H.P. against his transfer from GHS Khuthrin, Distt. Hamirpur to GMS Juru Shilal, U/C GMSSS Kupvi, Distt. Shimla, H.P. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 07-03-2025 when the Hon'ble High Court has passed the following orders:-

"5. Consequently, in view of above, this Court without going into the merits of the case, desms it fit to dispose of the present petition, with a direction to the competent authority to consider and decide the pending representation to the petitioner expeditiously, preferably within a period of ten days. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate order taking note of Clause 12.1 of the transfer policy. Liberty is reserved to the petitioners to file appropriate proceedings in appropriate court of law, if he still remains aggrieved. Till the time representation is not decided by the competent authority in terms of instant order, petitioner herein shall not be compelled to join at transferred station. Pending applications, if any, stand disposed of."

In compliance with the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 24-03-2025. He attended the same and submitted his representation in this office and requested that he may be adjusted in nearby his native place in Distt. Hamirpur, H.P. against vacancy/longer stay by clubbing his/her previous stay radius of 30 Kms. .

Whereas, from perusal of record, it has been found that the petitioner is working at GHS Khuthrin, Distt. Hamirpur, H.P. and is under transfer to GMS Juru Shilal, U/C GMSSS Kupvi, Distt. Shimla, H.P. which is a hard area and he has only three years of service left. One Sh. Pankaj Sharma, TGT(NM) is working in GHS Patnaun, Distt. Hamirpur, H.P since 04-10-2021. The petitioner has given willingness for his adjustment to the aforesaid school against longer stay by clubbing his/her previous stay within radius of 30 Kms. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetically, and he is hereby adjusted without TTA/JT at GHS Patnaun, Distt. Hamirpur, H.P vice Sh. Pankaj Sharma, TGT (NM), against longer stay and Sh. Pankaj Sharma, TGT(NM) is hereby transferred to GMS Juru Shilal, U/C GMSSS Kupvi, Distt. Shimla, H.P. with TTA/JT. The representation of the petitioner is disposed of accordingly.
