Whereas, Sh. Rajesh Kumar, TGT (NM) preferred in CWP No. 2466/2025 titled as Rajesh Kumar, TGT (NM) Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GSSS Dalgaon, Distt. Shimla, H.P to nearby home station in Distt. Hamirpur, H.P. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 19-02-2025, when the Hon'ble High Court has passed the following orders:-

7.(III) "Needless to say that this Court has not adverted to the merits and all questions are left open, which may be examined/ considered by respondents, hereinafter, in accordance with law. In aforesaid terms, the instant petition and all pending miscellaneous applications, if any, shall also stand disposed of."

In compliance with the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 24-03-2025. He attended the same and submitted his representation in this office, vide which he has requested that he has completed required tenure at his present place of posting at GSSS Dalgaon, Distt. Shimla, H.P and he may be transferred to nearby native place in Distt. Hamirpur, H.P, against vacancy/ longer stay by clubbing his/her previous stay radius of 30 Kms. .

Whereas, from perusal of record, it has been found that the petitioner is working at GSSS Dalgaon, Distt. Shimla, H.P. since, 22-12-2020 and has completed his normal tenure at his present place of posting. One Sh. Sanjay Kumar, TGT(NM) is working in GSSS Tal, Distt. Hamirpur, H.P. since 28-08-2023. The petitioner has given willingness for his transfer to the aforesaid school against longer stay by clubbing his/her previous stay within radius of 30 Kms. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetic, and he is hereby transferred without TTA/JT from GSSS Dalgaon, Distt. Shimla, H.P. to GSSS Tal, Distt. Hamirpur, H.P. vice Sh. Sanjay Kumar, TGT(NM), against longer stay by clubbing his previous stay within radius of 30 Kms. . With TTA/JT to Sh. Sanjay Kumar, TGT(NM). The representation of the petitioner is disposed of accordingly.
