ORDER

In compliance of the order/judgment passed by the Hon'ble High Court of Himachal Pradesh in CWP No. 2566/2025 titled as Seema Shabi, TGT (Arts) V/s State of H.P. on dated 25-02-2025, the petitioner was called for personal hearing on 30-12-2021 and appeared before the undersigned on scheduled date. The petitioner has stated that she has completed her normal tenure in hard area, therefore, requested for her transfer either to GSSS Nagrota Surian/ Balu Gloa/ Masroor/ Sakri/Bathri, District Kangra, against vacancy / longer stayee.

From the perusal of record, it is found that Smt. Seema Shabi, TGT (Arts) is working at GSSS Devi Kothi, (hard area) District Chamba since 04-03-2022 and has completed her normal tenure in hard area. At present one post of TGT (Arts) is vacant at GSSS Nagrota Surian district Kangra.

Keeping in view the position stated above, representation of petitioner is considered sympathetically and Smt. Seema Shabi, TGT (Arts) is hereby transferred from GSSS Devi Kothi District Chamba to GSSS Nagrota Surian district Kangra, against vacancy, without TTA/JT. Therefore, representation of the petitioner with the present CWP is disposed of accordingly.

In the matter of: CWP No. 2707/2025 titled as Ravi Kumar, TGT (NM) Vs. State of H.P. & ors.

Whereas, Sh. Ravi Kumar, TGT (NM) preferred CWP No. 2707/2025 titled as Ravi Kumar Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GHS Deval Tikkari u/c GSSS Kujji, Distt. Sirmour to the station nearby his native place in Distt. Una, against vacancy/ longer stayee by clubbing his/her previous stay. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 27.02.2025 when the Hon'ble High Court has passed the following orders:-

"3. Consequently, in view of aforesaid fair statement given by learned Additional Advocate General, this Court without going into the merits of the case, deems fit to dispose of the present petition, with a direction to respondents to decide the pending representation(s) of the petitioner, expeditiously, preferably, within a period of four weeks. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass speaking order thereupon taking note of provisions contained in the transfer policy, which admittedly provides for minimum tenure of posting of an employee at one station for three years. Liberty is reserved to the petitioner to file appropriate proceedings in appropriate Court of law, if he still remains aggrieved. Pending applications, if any, also stand disposed of."

In compliance of the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 12.03.2025. He has attended the same and submitted his representation in this office on 12.03.2025 vide which he has requested that he has completed normal tenure at his present place of posting i.e GHS Deval Tikkari u/c GSSS Kujji, Distt. Sirmour, H.P and he further requested that he may be transferred/adjusted in Distt. Una, against vacancy/ longer stayee by clubbing his/her previous stay.

From perusal of record, it has been found that the petitioner has been working at GHS Deval Tikkari u/c GSSS Kujji, Distt. Sirmour w.e.f. 15.11.2019 and has completed his normal tenure at his present place of posting. Moreover, TGT (NM) is State Cadre post and the incumbents supposed to serve anywhere in the state as per requirement and administrative exigency. At present 49 students are studying in GHS Deval Tikkari u/c GSSS Kujji, Distt. Sirmour and only one TGT^{NM} is working there. If the petitioner will be transferred from there, the studies of students will suffer adversely. Therefore, after critical examination and thoughtful application of mind the request made by the petitioner is hereby rejected on administrative ground and in larger public interest. The representation of the petitioner is disposed of accordingly.

In compliance with the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 24-03-2025. He attended the same and submitted his representation in this office, vide which he has requested that he has completed required tenure at his present place of posting at GHS Ananehar, U/C GSSS Lylh, Distt. Chamba, H.P. and he may be transferred to nearby native place in Distt. Hamirpur, H.P, against vacancy/ longer stay by clubbing his/her previous stay radius of 30 Kms. .

Whereas, from perusal of record, it has been found that the petitioner is working at GHS Ananehar, U/C GSSS Lylh, Distt. Chamba, H.P. since, 25-02-2022, which is a hard area and has completed his normal tenure at his present place of posting. One Sh. Praveen Kumar, TGT(NM) is working in GSSS Jangal Beri, Distt. Hamirpur, H.P. since 22-07-2022. The petitioner has given willingness for his transfer to the aforesaid school against longer stay by clubbing his/her previous stay within radius of 30 Kms.
