In the matter of: CWP No. 2917/2025 titled as Rohit Gupta, TGT (NM) Vs. State of H.P. & ors.

Whereas, Sh. Rohit Gupta, TGT (NM) preferred CWP No. 2917/2025 titled as Rohit Gupta Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GHS Puccatala, Distt. Chamba to the station nearby his native place in Distt. Kangra, against vacancy/ longer stayee by clubbing his/her previous stay. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 03.03.2025 when the Hon'ble High Court has passed the following orders:-

*"5. Consequently, in view of above, this Court without going into the merits of the case, deems it fit to dispose of the present petition with a direction to the respondents to consider and decide the pending representation dated 19.11.2024 (Annexure P-2) of the petitioner expeditiously, preferably within a period of four weeks. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass detailed order thereupon. Liberty is reserved to the petitioner to file appropriate proceedings in appropriate Court of law, if he still remains aggrieved. Pending applications, if any, also stand disposed of."*

In compliance of the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 24.03.2025. He has attended the same and submitted his representation in this office on 24.03.2025 vide which he has requested that he has completed normal tenure at his present place of posting i.e GHS Puccatala, Distt. Chamba, H.P. and he further requested that he may be transferred/adjusted in Distt. Kangra, against vacancy/ longer stayee by clubbing his/her previous stay.

From perusal of record, it has been found that the petitioner has been working at GHS Puccatala, Distt. Chamba w.e.f. 20.11.2021 and has completed his normal tenure at his present place of posting. Moreover, TGT (NM) is State Cadre post and the incumbents supposed to serve anywhere in the state as per requirement and administrative exigency. At present 27 students are studying in GHS Puccatala, Distt. Chamba and only one TGT(NM) is working there. If the petitioner will be transferred from there the studies of students will suffer adversely. Therefore, after critical examination and thoughtful application of mind the request made by the petitioner is hereby rejected on administrative ground and in larger public interest. The representation of the petitioner is disposed of accordingly.
