**ORDER**

In the matter of:

CWP No. 2802/2025-titled as Smt. Kalpna Dadwal (TGT Med.) V/s State of Himachal Pradesh and others (Regarding Transfer).

Smt. Kalpana Dadwal, TGT (Med.) has filed CWP No. 2802/2025 titled as Smt. Kalpna Dadwal V/s State of H.P. in the Hon'ble High Court, and seeking her transfer from GHS, Darwin U/c GSSS Devi Mehla Distt. Chamba either to GSSS, Jambal Distt Kgr, GHS Upper Balwal Distt. Kgr, GSSS, Behin Distt Kangra GSSS, Karoa Distt. Kangra or GSSS, Jwar Distt. Kangra. The case was listed before the Hon'ble High Court of H.P. on 28.02.2025, on this day Hon'ble Court has passed order/judgment. The Operative portion of the present CWP judgement is as under:-

*"Looking to the grievance of the petitioner, this writ petition is disposed of by directing respondent No.2/Competent Authority to consider and decide the aforesaid representation of the petitioner in accordance with law within a period of four weeks from today. The order so passed be also communicated to the petitioner.*

The petitioner i.e Smt. Kalpna Dadwal, TGT (Med.) was called for personal hearing but she did not appear. She has submitted fresh representation to transfer her at GSSS, Jambal Distt Kgr, GHS Upper Balwal Distt. Kgr, GSSS, Behin Distt Kangra GSSS, Karoa Distt. Kangra or GSSS, Jwar Distt. Kangra against longer stayee or by clubbing their previous stay against longer stay or by clubbing their previous stay.

From the perusal of record, it is found that Smt. Kalpna Dadwal, TGT (Med.) is working at GHS, Darwin U/c GSSS Devi Mehla Distt. Chamba since 22.02.2022. Moreover, GHS, Darwin U/c GSSS Devi Mehla Distt. Chamba falls in Sub-Cadre area and she has completed her normal tenure at present place of posting as per transfer policy.

Keeping in view the position stated above, representation of the petitioner i.e Smt. Kalpna Dadwal, TGT (Med.) is considered sympathetically and petitioner is hereby transferred from GHS, Darwin U/c GSSS Devi Mehla Distt. Chamba to GSSS, Karoa Distt. Kangra vice Sh. Shashi Kumar TGT (Med.) against longer stayee (with TTA/JT) to Sh. Shashi Kumar. Keeping in view the position stated above, representation of the petitioner i.e Smt. Kalpna Dadwal, TGT (Med.) is disposed of accordingly.

ORDER

In the matter of:

CWP No: 343/2025-titled as Vivek Thakur V/s. State of Himachal Pradesh (Regarding Transfer).

Sh. Vivek Thakur, TGT (Med.) has filed CWP No 343/2025 titled as Vivek Thakur V/s State of H.P. in the Hon'ble High Court, and seeking his transfer from GSSS, Murah District Mandi to Distt. Bilaspur or Distt. Hamirpur against vacancy or against any longer stayee. The case was listed before the Hon'ble High Court of H.P. on 06.01.2025, on this day Hon'ble Court has passed order/judgment. The Operative portion of the present CWP judgement is as under :-

*"This writ petition is accordingly disposed of with the direction that let the representation made by the petitioner, appended with the writ petition as Annexures P-4 and P-5, shall be decide by the competent."*

In compliance to the aforesaid orders passed by the hon'ble High Court of Himachal Pradesh, the petitioner Sh. Vivek Thakur, TGT (Med.) has attended the personal hearing on 29.03.2025 and has submitted representation, wherein request to transfer him from GSSS, Murah Distt. Mandi to Distt. Bilaspur or Distt. Hamirpur

From the perusal of record, it is found that Sh. Vivek Thakur, TGT (Med.) is working in GSSS, Murah Distt. Mandi since August 2018 (Soft area) and has completed normal tenure at his present place of posting. Moreover, the petitioner is working in soft area and he is not entitled for transfer to choice station despite the fact that TGT's is State Cadre post and the incumbents are supposed to serve anywhere in the State.

As per provision contained in comprehensive guidelines Principles-2013 for regulating the transfer of State Government employees. It is specifically mentioned in Para 12.1 "Transfer to a particular place of choice cannot be claimed as a matter of right. It will be the discretion of the State Govt., to post/transfer any employee anywhere in the state, keeping in view of the administrative exigencies/convenience.

Keeping in view, the above facts and circumstances, the case of the petitioner for transfer cannot be considered at this stage. Hence, request made by the petitioner is hereby rejected. The representation of the petitioner is disposed of accordingly.

**ORDER**

In the matter of: CWP No. 3003/2025-titled as Smt. Sanvali Devi (TGT Med.) V/s State of Himachal Pradesh and others (Regarding Transfer).

Smt. Sanvali Devi, TGT (Med.) has filed CWP No. 3003/2025 titled as Smt. Sanvali Devi V/s State of H.P. in the Hon'ble High Court, and seeking her transfer from GSSS, Batot Distt. Chamba either to GHS, Bhagotla, GSSS Chachian, GHS Bhattu Samula, GSSS, Sidhpur Sarkari, GSSS, Rajpur, GSSS, Saloh, GSSS, Jia Distt. Kangra or GSSS, Hatli Distt. Chamba. The case was listed before the Hon'ble High Court of H.P. on 04.03.2025, on this day Hon'ble Court has passed order/judgment. The Operative portion of the present CWP judgement is as under:-

*"Consequently, in view of the above, this Court, without going into the merits of the case, deems it fit to dispose of the present petition, with a direction to the respondents to consider and decide the pending representations dated 13.12.2024 and 20.02.2025 filed by the petitioner expeditiously, preferably within a period of four weeks from today. Orders accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass speaking order thereupon taking note of provision contained in the transfer policy. Pending applications, if any, stand disposed of."*

The petitioner i.e Smt. Sanvali Devi, TGT (Med.) was called for personal hearing and she appeared before the undersigned on 29.03.2025. At the time of hearing she has submitted fresh representation vide which she stated that she has lost her husband recently and now, she is a single parent to her minor son, who is residing with maternal parents in Kangra. So, she has requested to adjust her at GHS, Bhagotla, GSSS Chachian, GHS Bhattu Samula, GSSS, Sidhpur Sarkari, GSSS, Rajpur, GSSS, Saloh, GSSS, Jia Distt. Kangra or GSSS, Hatli Distt. Chamba.

From the perusal of record, it is found that Smt. Sanvali Devi, TGT (Med.) is working at GSSS, Batot Distt. Chamba since 21.02.2022. Moreover, GSSS, Batot Distt. Chamba falls in Sub-Cadre area and she has completed her normal tenure at present place of posting as per transfer policy.

Keeping in view the position stated above, representation of the petitioner i.e Smt. Sanvali Devi, TGT (Med.) is considered sympathetically and petitioner is hereby transferred from GSSS, Batot Distt. Chamba to GSSS, Saloh Distt. Kangra vice Sangita Supheia Mandiyal TGT (Med.) (By clubbing her previous stay) with TTA/JT to Smt. Sangita Supheia. TGT (Med.) Keeping in view the position stated above, representation of the petitioner i.e Smt. Sanjay Bala, TGT (Med.) is disposed of accordingly.
