Whereas, Sh. Balwinder Singh, TGT (NM) preferred in CWP No. 2994/2025 titled as Balwinder Singh, TGT (NM) Vs. State of H.P. before the Hon'ble High Court of H.P regarding his transfer from GMS Sanahan, U/C GSSS Lylh, Distt. Chamba, H.P (Hard Area) to nearby home station (Soft Area) in Distt. Kangra, H.P. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 04-03-2025, when the Hon'ble High Court has passed the following orders:-

3. " Taking into consideration the aforesaid submissions, this writ petition is disposed of by directing respondent No. 2/competent authority to consider and decide the aforesaid representation of the petitioner dated 23-08-2024 in accordance with law and applicable transfer policy within a period of four weeks from today. The decision so arrived at shall also be communicated to the petitioner. The writ petition stands disposed of in the above terms, so also the pending miscellaneous application(s), if any.

In compliance with the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 22-03-2025. He attended the same and submitted his representation in this office, vide which he has requested that he has completed required tenure at his present place of posting at GMS Sanahan, U/C GSSS Lylh, Distt. Chamba, H.P and he may be transferred to nearby native place in Distt. Kangra, H.P, against vacancy/ longer stay by clubbing his/her previous stay radius of 30 Kms. .

Whereas, from perusal of record, it has been found that the petitioner is working at GMS Sanahan, U/C GSSS Lylh, Distt. Chamba, H.P since, 24-02-2022 which is a hard area and has completed his normal tenure at his present place of posting. One Sh. Krishan Kumar, TGT(NM) is working in GHS Balahra, U/C GSSS Lahru, Distt. Kangra, H.P. since 16-01-2021. The petitioner has given willingness for his transfer to the aforesaid school against longer stay by clubbing his/her previous stay within radius of 30 Kms. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetic, and he is hereby transferred without TTA/JT from GMS Sanahan, U/C GSSS Lylh, Distt. Chamba, H.P to GHS Balahra, U/C GSSS Lahru, Distt. Kangra, H.P. vice Sh. Krishan Kumar, TGT(NM), against longer stay. With TTA/JT to Sh. Krishan Kumar, TGT(NM). The representation of the petitioner is disposed of accordingly.
