Chamba, H.P and he may be transferred to nearby native place in Distt. Kangra, H.P, against vacancy/ longer stay by clubbing his/her previous stay radius of 30 Kms. .

Whereas, from perusal of record, it has been found that the petitioner is working at GMS Sanahan, U/C GSSS Lylh, Distt. Chamba, H.P since, 24-02-2022 which is a hard area and has completed his normal tenure at his present place of posting. One Sh. Krishan Kumar, TGT(NM) is working in GHS Balahra, U/C GSSS Lahru, Distt. Kangra, H.P. since 16-01-2021. The petitioner has given willingness for his transfer to the aforesaid school against longer stay by clubbing his/her previous stay within radius of 30 Kms. Keeping in view of the position stated above, the representation of the petitioner is considered sympatheticay, and he is hereby transferred without TTA/JT from GMS Sanahan, U/C GSSS Lylh, Distt. Chamba, H.P to GHS Balahra, U/C GSSS Lahru, Distt. Kangra, H.P. vice Sh. Krishan Kumar, TGT(NM), against longer stay. With TTA/JT to Sh. Krishan Kumar, TGT(NM).
