In the matter of: CWP No. 11101/2024-titled as Upma Dogra, Vs. State of H.P. & Others.

Whereas, Smt. Upma Dogra, TGT (NM) preferred CWP No. 11101/2024 titled as Upma Dogra, Vs. State of H.P. before the Hon'ble High Court of H.P. regarding her transfer from GMS Uslad, U/C GSSS Batot, Distt. Chamba, H.P. to nearby station at her native place in Distt. Kangra, H.P. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 01-10-2024 when the Hon'ble High Court has passed the following orders:-

*"3. " It is evident from the documents appended with the petition that the petitioner has indeed completed a tenure of two winters and three summers in a hard area, therefore, this writ petition is disposed of with the direction that let the petitione be transferred out of the said station when general transfers will effect in the Education Department, in the light of the representation of the petitioner, by posting her, if possible at one of the ststion mentioned in the representation and if that is not possible then by adjusting him nearby, on priority basis. pending miscellaneous applications, if any, also stand disposed of."*

In compliance with the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 19-11-2024. She attended the same and submitted her representation in this office on 19-11-2024, vide which she has requested that she may be transfer from GMS Uslad, U/C GSSS Batot, Distt. Chamba, H.P. to nearby station at her native place in Distt. Kangra, H.P. against vacancy/ against longer stay by clubbing his/her previous stay radius of 30 Kms., being a couple case.

From perusal of record, it has been found that the petitioner has been working at GMS Uslad, U/C GSSS Batot, Distt. Chamba, H.P (sub-cadre/hard area) w.e.f 02-03-0222 and has completed her normal tenure at present place of posting. One Sh. Deep Kumar, TGT(NM), is working in GSSS Naura, Distt. Kangra, H.P. since 25-11-2021. The petitioner has given willingness for her transfer to the aforesaid school against longer stay by clubbing his/her previous stay within radius of 30 Kms. Keeping in view of the position stated above, the representation of the petitioner is considered sympatheticay, and She is hereby transferred without TTA/JT from GMS Uslad, U/C GSSS Batot, Distt. Chamba, H.P. to GSSS Naura, Distt. Kangra, H.P. vice Sh. Deep Kumar, TGT(NM), against longer stay. With TTA/JT to Sh. Deep Kumar, TGT(NM). The representation of the petitioner is disposed of accordingly.
