**ORDER**

In the matter of: CWP No. 3885/2025-titled as Smt. Sapna Choudhary (TGT Med.) V/s State of Himachal Pradesh and others (Regarding Transfer).  
Smt. Sapna Choudhary, TGT (Med.) has filed CWP No. 3885/2025 titled as Smt. Sapna Choudhary V/s. State of H.P. in the Hon'ble High Court, and seeking her transfer from GHS, Deol Distt. Chamba to GHS, Ludhian u/c GSSS, Paloura, GSSS, Barot, GSSS, Maira, GSSS, Sidhpur, GHS, Larth u/c Raja ka Talab, GSSS, Sukhar, GSSS, Chhatter, GMSSS, Fatehpur, GSSS, Houri Devi, GSSS, Garan Distt. Kangra against longer stayee. The case was listed before the Hon'ble High Court of H.P. on 20.03.2025, on this day Hon'ble Court has passed order/judgment. The Operative portion of the present CWP judgement is as under:-

*"Consequently, in view of the above, this Court, without going into the merits of the case, deems it fit to dispose of the present petition, with a direction to the respondents to consider and decide the pending representations (Annexure P-1) filed by the petitioner expeditiously, preferably within a period of four weeks from today. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of being heard to the petitioner and pass appropriate orders thereupon taking note of Transfer Policy formulated by Government of Himachal Pradesh. Pending applications, if any, stand disposed of.*

The petitioner i.e Smt. Sapna Choudhary, TGT (Med.) was called for personal hearing and she appeared before the undersigned on 08.04.2025. At the time of hearing she has submitted fresh representation vide which she stated that she has completed her normal tenure in Tribal area of Distt. Chamba and has requested to adjust her GHS, Ludhian u/c GSSS, Paloura, GSSS, Barot, GSSS, Maira, GSSS, Sidhpur, GHS, Larth u/c Raja ka Talab, GSSS, Sukhar, GSSS, Chhatter, GMSSS, Fatehpur, GSSS, Houri Devi, GSSS, Garan Distt. Kangra against longer stayee.

From the perusal of record, it is found that Smt. Sapna Choudhary, TGT (Med.) is working at GHS, Deol Distt. Chamba since 25.02.2022. Moreover, GHS, Deol Distt. Chamba falls in Tribal area and she has completed her normal tenure at present place of posting as per transfer policy.

Keeping in view the position stated above, representation of the petitioner i.e Smt. Sapna Choudhary, TGT (Med.) is considered sympathetically and petitioner is hereby transferred from GHS, Deol Distt. Chamba to GSSS, Houri Devi Distt. Kangra vice Smt. Meena Kumari TGT (Med.) against longer stayee (with TTA/JT) to Smt. Meena Kumari. Keeping in view the position stated above, representation of the petitioner i.e Smt. Meena Kumari, TGT (Med.) is disposed of accordingly.
