From the perusal of record, it is found that Sh. Rajesh Kamal, TGT (Arts) is working at GHS Nalyana, Distt. Mandi (Soft area) since 17.06.2021 and has completed his normal tenure. At present post of TGT (Arts) is not lying vacant in ibid mentioned schools, however one Smt. Neelma Kumari, TGT (Arts) is working at GMS Saroun Distt. Mandi since 14.12.2020 and completed her normal tenure at present place of posting.

Keeping in view the position stated above, representation of the petitioner i.e Sh. Rajesh Kamal, TGT (Arts) is considered sympathetically and petitioner is hereby transferred from GHS Nalyana, Distt. Mandi to GMS Saroun Distt. Mandi vice Smt. Neelma Devi, TGT (Arts) and vice versa (being longer stayee), (with TTA/JT to Smt. Neelma Devi). Therefore, representation of the petitioner with the present CWP is disposed of accordingly.
