## ORDER

Whereas, Sh. Bhim Dev Thakur, Lecturer (School-New) (Economics) was filed CWP No. 4890/2025 before the Hon'ble High Court regarding to decide his representation vide which he has seeking his transfer from GSSS Baga Chanogi Thach, Distt. Mandi to choice of stations on the grounds that he has already served in hard area several times as well as he is suffering from chronic heart disease.

The case was listed before the Hon'ble Court on 3.4.2025 when the case was disposed of with the following directions:-

"Looking to the limited grievance of the petitioner, this writ petition is disposed of by directing respondent No.2/Competent Authority to consider and decide the aforesaid representation of the petitioner in accordance with law and as per applicable transfer policy within a period of six weeks from today. The decision so taken be also communicated to the petitioner".

And whereas, upon passing of above directions, petitioner, Sh. Bharat Singh, Lecturer (School-New) (Economics) submitted a fresh representation vide which he has given his choice of stations i.e. GSSS Dhaner Patrighat/ GSSS Bhambla, Distt. Mandi against longer stayee and GSSS Jamni, Distt. Mandi against vacant post due to retirement of present incumbent on 30.6.2025.

And whereas, that the matter has been examined on the basis of report received from the Deputy Director of Higher Education, Mandi. Presently, Sh. Rajinder Kumar, Lecurer (Economics) is posted at GSSS Dhaner Patrighat (MND) w.e.f 26.8.2023 and Sh. Kashmiri Lal, Lecturer (Economics) is posted at GSSS Bhambla (MND) w.e.f. 4.8.2022 and having short stay of both incumbents at present place of posting. Therefore, petitioner cannot be transferred to these stations. However, post of Lecturer (Economics) is going to vacant at GSSS Jamni (Mandi) on 30.6.2025.

**Now therefore,** after taking into account the above facts and circumstances of the case, representation of petitioner is considered sympathically and the petitioner i.e. Sh. Bhim Dev Thakur, Lecturer (School-New) (Economics) is hereby transferred from GSSS Baga Chanogi Thach (Mandi) to GSSS Jamni (Mandi) against vacancy being caused due to retirement of present incumbent on 30.06.2025 without TTA/JT as per petitioner request.

Note:- These orders shall come into force on or after 01.07.2025.

With these observations, representation stands disposed of.
