CWP No. 4996/2025-titled as Upender Kaundal Vs. State of H.P. & Others.

Whereas, Sh. Upender Kaundal, TGT (NM) preferred CWP No. 4996/2025 titled as Upender Kaundal, Vs. State of H.P. before the Hon'ble High Court of H.P. regarding his transfer from GHS Thakur Dwara, Distt. Kangra, H.P. to GSSS Tangling Distt. Kinnaur, HP. The above writ petition was listed before the Hon'ble High Court, Himachal Pradesh on 04-04-2025 when the Hon'ble High Court has passed the following orders:-

*"5. Having regard to the afore-submissions, but without examining the merits of the matter, this writ petition is disposed of by permitting the petitioner to file a comprehensive representation to the respondent No.2/ competent authority, seeking his adjustment, within three days from today. In case such a representation is received by respondent No. 2/competent authority within the aforesaid period, the same shall be considered and decided in accordance with law and applicable transfer policy, within ten days thereafter. The decision so arrived at shall also be communicated to the petitioner. The writ petition stands disposed of in the above terms, so also the pending miscellaneous applications(s) if any."*

In compliance with the aforesaid orders of the Hon'ble High Court the petitioner was called for personal hearing on 25-04-2025. He attended the same and submitted his representation in this office on 25-04-2025, vide which he has requested that he may be transfer/ adjusted nearby station at his native place in Distt. Kangra, H.P. against vacancy/ against longer stay by clubbing his/her previous stay radius of 30 Kms. .

From perusal of record, it has been found that the petitioner has been working at GHS Thakur Dwara, Distt. Kangra, H.P. and under transferred to GSSS Tangling Distt. Kinnaur, HP. One Sh. Manoj Kumar, TGT(NM) is working in GHS Bhagsunag, Distt. Kangra, H.P. since 10-11-2023. The petitioner has given willingness for his transfer to the aforesaid school against longer stay by clubbing his/her previous stay within radius of 30 Kms. Keeping in view of the position stated above, the representation of the petitioner is considered sympathetic, and he is hereby adjusted at GHS Bhagsunag, Distt. Kangra, H.P. without TTA/JT vice Sh. Manoj Kumar, TGT(NM) against longer stay by clubbing his previous stay within radius of 30 Kms. and Sh. Manoj Kumar is hereby transferred to GSSS Tangling Distt. Kinnaur, HP. with TTA/JT to Sh. Manoj Kumar, TGT(NM). The representation of the petitioner is disposed of accordingly.
