ORDER

In the matter of: CWP No. 867/2025 titled as Dhruy Kumar, PET vs. State of H.P. & others (Reg. Transfer under 5% quota).

Sh. Dhruv Kumar is presently working as PET at GSSS Devgarh, District Shimla. The petitioner has filed a CWP No. 867/2025 titled as Dhruv Kumar, PET vs. State of H.P. & others regarding to transfer him from GSSS Devgarh. District Shimla to GSSS Jadrangal, Tehsil Dharamshala, District Kangra under 5% inter district transfer quota wherein the Hon'ble High Court of Himachal Pradesh was pleased to pass the following orders:-

> "3. This writ petition is accordingly disposed of with the direction that the representation made by the petitioner, appended with the writ petition as Annexure P-1, shall be decided by the competent Authority, sympathetically, in light of the averments made therein, within a period of two weeks from today, by passing a speaking order, in accordance with law and if possible, the petitioner be adjusted at a station of his choice as mentioned in the representation P-1. If need so arises, the petitioner be given opportunity of personal hearing before deciding his representation. Pending miscellaneous application(s), if any, also stand disposed of accordingly."

That in compliance to the directions of the Hon'ble High Court of H.P. the petitioner was called for personal hearing on 25.04,2025 and the applicant attended the personal hearing on scheduled date and time and was heard at length. During the course of hearing, the applicant requested that he may be transferred from GSSS Devgarh to GSSS Jadrangal, Kangra against vacant post under 5% inter district quota.

That the matter has been examined in light of 5% inter district policy and on the basis of report received from the Deputy Director of School Education, Shimla and Kangra, it is revealed that Sh. Dhruv Kumar is working as PET in District Shimla since 18.12.2018 on Contract basis and his services were regularized on 21.01.2022. As per 5% inter district transfer policy dated 20th November, 2021, he has completed his normal stay of 5 years in present District, the vacancy is available in District Kangra and 5% quota is also available.

In view of the facts narrated above, the representation of Sh. Dhruv Kumar, PET is hereby disposed of after due consideration and he may be transferred from GSSS Devgarh, District Shimla to GSSS Jadrangal, Tehsil Dharamshala, District Kangra, against vacant post, without TTA/JT under 5% quota policy.
