ORDER

Whereas, Sh. Jeewan Singh, Lecturer (School-New) (Economics) was filed CWP No. 2227/2025 before the Hon'ble High Court regarding to decide his representation vide which he has seeking his transfer from GSSS Spail, Distt. Kangra to one of the station of his choice as he has already completed his normal tenure at present place of posting and medical problems of his mother.

The case was listed before the Hon'bie Court on 25.02.2025 when the case was disposed of with the following directions:-

"Consequently, in view of the above, this Court without going into the merits of the case, deems it fit to dispose of the present petition with a direction to the Director Higher Education, Himachal Pradesh to consider and decide the pending representation dated 03.01.2024 (Annexure P-2) of the petitioner expeditiously, preferably within a period of four weeks. Ordered accordingly. Needless to say, authority concerned, while doing the needful in terms of instant order, shall afford an opportunity of hearing to the petitioner and pass detailed speaking order thereupon. Liberty is reserved to the petitioner to file appropriate proceeding in appropriate court of law, if he still remains aggrieved".

And whereas, upon passing of above directions, petitioner, Sh. Jeewan Singh, Lecturer (Economics) submitted his fresh representation vide which he has given his choice of stations i.e. GSSS Passu/Bagli/Serathana/Kaned, Distt. Kangra against vacancy. But post is not lying vacant at GSSS Passu (Kangra).

And whereas, that the matter has been examined and found that post of Lecturer (Economics) is lying vacant at GSSS Bagli/Serathana/Kaned but petitioner is posted in soft area and as per "Comprehensive Guiding Principles-2013" for regulation the transfer of State Government employees it is clearly mentioned at Rule-12.1 that no government employee can claim his transfer or posting as a matter of right. It will be the discretion of the State Government to post/transfer any employee anywhere in the State keeping in view of the administrative exigencies/convenienceon.

Now therefore, after taking into account the above discussed detailed facts and circumstances, a request of the petitioner cannot be acceded to. Hence in view of ongoing facts, representation of the petitioner has been considered and rejected.

With these observations, representation stand disposed of.
