However, it is pointed out here that where the online computer internet facility is not available at school level the format may be got filled up at nearest GSSS/GHS or at respective BEEO level where such facility is available on priority basis in a time bound manner as per the Hon'ble Supreme Court orders/ directions.

In view of the above, you are therefore directed to issue necessary instructions to all the schools to fill up the requisite information on the aforesaid prescribed format upto 31.5.2017. The respective schools have to fill the form at school level or get it filled the at nearest GSSS/GHS or at BEEO level on priority basis in a time bound manner up to 31-05-2017 as per the Hon'ble Supreme Court orders/ directions.
