(1) In all cases of promotion, the continuous adhoc service rendered in the feeder post upto 31-3-1998, if any, prior to regular appointment to the post shall be taken into account towards the length of service as prescribed in these Ryles for promotion subject to the condition that adhoc appointment/promotion in the feeder category had been made after following proper acceptable process of selection in accordance with provisions of R & P Rules, provided that in all cases where a junior person becomes eligible for consideration by virtue of his total length of service (including the service rendered on adhoc basis upto 31-3-98 followed by regular service/appointment in the feeder post in view of the provisions referred to above all persons senior to him in the respective category/post/ cadre shall be deemed to be eligible for consideration and placed above the junior person in the field of consideration:

Explanation:- The last proviso shall not render the junior incumbents ineligible for consideration for promotion if the senior ineligible persons happened to Ex-servicemen recruited under the provisions of Rule-3 of Domobilised Armed Forces Personne!
